- **3. Taxes:** Labor cess @ 1% & GST @ 18% is extra {i.e. not included Rate in Rs. per Hour (ESIC Zone III) of Schedule "A"}.
- 4. Validity: Quotation should have validity of 90 days.
- **5. Important Dates**: Quotations are invited from 17.03.2022 from 10:00 hrs, so as to reach this office up to 23.03.2022 up to 17:00 hrs and the same will be opened on the same day, if possible.
