DUE DATE: The RFx, complete in all respects, should be submitted between the periods of 16.03.2022 to 23.03.2022 positively.

TERMS AND CONDITIONS

- 1. The period of contract shall be from "01.04.2023 or the date of placing of work order for this tender to 31.03.2023".
- 2. Rates should be firm and should include all charges such as duties, all types of taxes (Including GST), etc. complete.
- 3. You will have to attend quarterly or as and when required for the purpose of servicing/ cleaning.
- 4. AMC works involves quarterly servicing of all air conditioners and attending breakdown immediately on intimation, failing to attain the same will result in penalty @ Rs.200/- will be charged, maximum response period will be of Forty eight hours for each break down call.
- 5. If air conditioners are required to be repaired at your shop necessary transportation expenses shall be paid by you.
- 6. The bill for charges should be given quarterly which shall be paid on certifying by the concerned Engineer-in-charge on submission of bill in triplicate.
- 7. The undersigned reserves the right to reject any or all quotations without assigning any reasons.
- 8. Taxes, if any, should be mentioned extra, if not mentioned, it will be considered as inclusive of all taxes & charges.
- 9. Income tax, Insurance, Labour cess, GST or any other taxes as applicable will be recovered from the bill on the total value of the work done as per the prevailing rates.
- 10. The tenderer must possess the following documents and they should essentially submit certified/ Attested scanned copies of the same, otherwise, the tenderer will be dis-qualified.
 - a) Valid Mumbai Shop Act certificate.
 - b) Goods & Service Tax (GST) registration certificate (If applicable). If not applicable, certificate from CA with UDIN number stating that GST registration is not applicable to you.
 - c) Copy of Company/Firm Pan Card.
 - d) Income Tax Returns for last three assessment years (2019-20, 2020-21, 2021-22)
 - e) Udyog Aadhar Certificate (if exempted from EMD payment). (MSME Certificate).
 - f) The bidder should have the experience certificate for the above Air Conditioner (AC) AMC work at office executed in last three years in MSETCL or other utility or other company Pvt. Ltd. shall be submitted (at least 60% of the estimated value.)

The above qualifying requirements are available in the question format in the RFx. The bidder has to answer all the questions at the time of bidding and also the supporting documents as required above shall be uploaded by the bidder. The documents will require digital signature at the time of uploading to the SRM Portal, the bidder has to connect the digital signature key at the time of uploading the Qualifying documents / any attachment.

- 11. Contractor will have to pay Security deposit at the office of Superintending Engineer, EHV Projects Circle, M.S.E.T.C.L., Kalwa or in the form of cash Demand Draft of any schedule bank drawn in favour of "Superintending Engineer, EHV Projects Circle, M.S.E.T.C.L., Kalwa" only equal to 5 % of the value of the order and submit the same to this office within seven days from the date of receipt of work order. No interest will be allowed on this deposit. If on breach of contract during contract period, S.D will be forfeited without assigning any reason. The amount will be refunded after expiry of warranty period subjected to deduction, if any forfeited as per the terms and condition.
- 12. The rates for this e-Tender shall be valid for 120 days period from the due date of submission of the e-Tender.

- 13. Whenever there is paucity of funds, the priority of payments of bills of various agencies will be decided by the undersigned and all the rights in this regards are reserved with the undersigned and binding upon you. The contractor is not entitled to claim any interest / compensation due to delay in their payments of bills on account of paucity of funds.
- 14. The undersigned reserves the right to cancel the contract, after giving due notice to the contractor, in the event of the breach of contract in any respect or undue delay in execution of work/starting of the work. If the contract is terminated because of the vendor, the security deposit will be forfeited. The contractors shall employ and provide on-site only such employees who are skilled and experienced for execution and supervision of works. The contractor shall provide housing accommodation to his employees. The contractor should ensure that his staff uses the requisite safety equipment. The employees should be duly insured against any such eventuality.
- 15. The contractors shall be responsible for any injury / accident to his employees, payment of compensations; insurance etc. as may require to be paid eventually, shall be borne by the contractor himself. The work should be carried out as per Board's work regulation.
- 16. All disputes, differences related to the tender/contract shall be subject to the exclusive jurisdiction of Thane District Court.
- 17. If the personal is found sleeping/ unsatisfactory work, absent, mis-behaviour or any other objectionable activity, penalty proportionate to monthly rate will be deducted from the bill.
- 18. Income tax or any other taxes as applicable will be recovered from your bills on the total value of the work done as per the prevailing rates.
- 19. Bidder should not submit "Conditional offer", such conditional offer shall be liable for rejection.
- 20. If the bidder has any doubt regarding meaning of any portion of the enquiry conditions/ specification, he should get clarified from the office of the undersigned.
- 21. Dispute: In case of any disputes, the decision of the undersigned shall be final and binding on the contractors.
- 22. The MSETCL's general/Technical/Commercial condition for work contract are also application and will be binding on bidder, Right to reject any or all quotations without assigning any reason is reserved by the undersigned.
- 23. The manpower required for this job will have to be arranged by you.
- 24. All expenditure on material shall be borne by you.
- 25. Other standard terms and conditions of MSETCL for order will be application in this case also.
- 26. The contractor have to submit contract agreement on Bond paper of Rs. 500.00/-.

Notwithstanding anything stated herein, the M.S.E.T.C.L.'s General Terms and Conditions of Contract shall also be applicable to this contract.
