TERMS AND CONDITIONS

- 1. Rates shall be quoted as per the Schedule "A" enclosed. Any changes must be brought out clearly.
- 2. The rates should be inclusive of To & Fro charges.
- 3. Quotations should be submitted in Two bids one Envelop containing, Technical Bid and other containing Commercial Bid. Sealed envelop containing Xerox copies of qualifying documents as below is to be submitted mentioning on the top of the envelop <u>"TECHNICAL BID":</u>-
- Shop Act/NOC from Grampanchayat
- Pan Card
- GST Certificate
- Purchase Invoice (Medium Size)
- 4. Quotation must be submitted along with the Xerox copies of all the documents pertaining to the Air cooler viz Purchase invoice, Servicing receipt., Specification details etc.
- 5. The rates should be quoted on your firms letter head as per 'Schedule A' in sealed separate envelop mentioning on top of envelop "COMMERCIAL BID"
- 6. The Electricity charges shall be borned by MSETCL.

7. During order period, Air cooler should work in good condition.

8. Estimated rates are including filling of water by the contractors representative daily at 10:00am at EHV Pr. Div. Office and Ganeshkhind office. Water shall be taken from the

premises of MSETCL.

9. All the repairing, breakdown and maintenance charges will be borne by the contractor. And alternative arrangement of air cooler shall be made by you immediately without any extra

charges to MSETCL.

10. It should be seen that Air cooler is kept in good running condition. The model of the Air

cooler should not be more than 5 years old.

11. In case any accident, mishap occurs during transportation, all the liabilities will be at contractor's cost & risk & alternative arrangement of air cooler shall be made by you immediately. M.S.E.T.C.L. will not pay any compensation to the contractor against any

damages or injuries to the air cooler arise at any circumstances.

12. Bill will be paid every month for actual working months and you will have to submit the bill

in triplicate to the Executive Engineer, EHV Projects Dn-II, Pune.

13. Applicable taxes as per the prevailing rates will be deducted from your bill. You should

submit Xerox copies of PAN Card, Shop act license & GST registration along with quotation.

14. Contractor have to execute the agreement for hiring of air coolers for Technical, F&A, HR Section at EHV Projects Dn-II, Pune & its underlying subdivision offices. The cost of stamp

paper will be born by contractor.

15. PAN Card No., GST No. & mobile no. should be mentioned on quotation & bill invoice.

16. Duration of hiring of Air cooler shall be for 3 months from the date of issuance of order

thereafter can be extended/reduced if required.

17. Contractor should have telephonic facility so that he can be contacted at any time.
