The terms and conditions are as follows: -

Terms & conditions: -

1. The rates shall be offered as per **Schedule “A”**.
2. Validity period of offer should be not less than 90 days from the date of opening of offer.
3. **Time limit:** The total time limit allowed for above work is 60 days from the date of issue of LOI/work order.
4. **Penalty:** If the material is not supplied within prescribed time limit, penalty at the rate ½ % percent per week delayed or part thereof subject to maximum upto 10% of work order values will be levied from your bill.
5. **Brief scope of work : The scope of work includes-**
 - a) Measurement of Tower footing Resistance by using Taurus or equivalent Tower Footing measurement kit provided by Contractor.
 - b) Detail record of resistance values of each tower along with date, name of line, location no. etc should be maintained and to be submitted to concern in-charge.
 - c) Remarks if any for improving tower footing resistance will be welcomed.
 - d) Agency will use their own vehicle, manpower & other resources.
 - e) MSETCL representative will monitor & guide during the execution of work
6. **Qualifying Criteria** – Valid PAN card copy, ITR for last three years, Valid GST registration certificate, valid labour insurance, Valid Electrical licence Proof of valid registration of firm under Bombay shop & Establishment Act/SSI/ NSIC if applicable & executed work order copy for similar work in Govt/Semi Govt/Private organisation must be submitted along with the offer.
7. **Submission of Bill:** Bills in triplicate should be submitted to the office of the The Executive Engineer, EHV(O&M) Division, Buldhana along with advance stamped receipt.
8. **Taxes** - The taxes such as TDS, Labour cess & all other taxes as applicable will be deducted from your bills.

9. **Payment:** 100% payment will be made against successfully supply of material. Payment will be made by EHV O&M Division, Buldhana against receipt of supply in good conditions & against Goods receipt, quality inspection of material in SAP.
10. **Agreement** - An agreement is required to be executed by bidder with the company on stamp paper of Rs. 500/- as per enclosed format. The cost of the stamp paper should be borne by you.
11. **Security Deposit** - The contractor will have to paid security deposit @ 5 % of value of the work order amount before commencement of contract in terms of DD/Check/BG/FDR and the DD/Check/ should be drawn in favour of The Executive Engineer, EHV (O&M) Division,Buldhana. The amount of SD will be refunded after satisfactory completion of contract period otherwise it will be forfeited without entertaining any objection/request thereof.
12. The Company's general terms and conditions of contract shall be applicable to this contract and will be bind on you.
13. Right to reject any or all quotations without assigning any reasons is reserved by the undersigned.
14. **Termination of order:** Failure to execute the order in time/ as per specification or any breach of the condition of contract, will result in termination of the contract.
