TERMS & CONDITIONS:

- 1. DUE DATE: The quotation completed in all respect, duly sealed & super scribed should be submitted to this office either in person/post on or before Dtd.28.03.2022 upto 18:00 Hrs positively.
- 2. DOCUMENTS TO BE SUBMITTED ALONG WITH OFFERS: Please submit the following documents along with offer:
 - a. Income Tax Return for Last Financial years i.e.2020-21.
 - b. Registration under PAN & GST.
 - & Establishment Act/NOC from local c. Registration under Bombay Shop Grampanchayat.
- 3. **ESTIMATED COST**:- The estimated cost is limited upto **Rs.61,847**/- including of all.

- 13. **EXECUTION OF WORK:** In the event of the offer being accepted in the whole, the successful contractor shall execute the order immediately as per the order schedule within the time specified in the work order.
