- 1. **DUE DATE**:- The quotation completed in all respect, duly sealed & super scribed should be submitted to this office either in person/post on or before Dtd.12.04.2022 upto 18:00 Hrs positively.
- 2. DOCUMENTS TO BE SUBMITTED ALONG WITH OFFERS :- Please submit the following documents along with offer:
  - a. Income Tax Return for Last Two Financial years i.e.2019-20 & 2020-21.
  - b. Registration under PAN & GST.
  - Shop & Establishment Act/NOC local from c. Registration under Bombay Grampanchayat.
