Sealed & superscripted quotations are invited for above as per enclosed Schedule 'A'. You are requested to quote your reasonable rates for the above subjected work. The terms & conditions are as follows:

#### **TERMS & CONDITIONS:**

- 1. DUE DATE:- The quotation completed in all respect, duly sealed & super scribed should be submitted to this office either in person/post on or before Dtd.27.04.2022 upto 18:00 Hrs positively.
- 2. DOCUMENTS TO BE SUBMITTED ALONG WITH OFFERS :- Please submit the following documents along with offer:
  - a. Valid Electrical Contractor license, if available.
  - b. Income Tax Return for Last Financial years i.e.2020-21.
  - c. Registration under PAN & GST.
  - d. Valid Insurance for the employees deputed by you as per MSETCL Circular No.14419 Dtd.07.11.2013 OR Undertaking regarding the same.
- 3. ESTIMATED COST: The estimated cost is limited upto Rs.05,310/- including all.
- 4. QUOTED RATES: The quoted rates should include the cost of all taxes. The taxes will be clearly mentioned, & if the taxes are not clearly mention, then it will be presumed that the rates are inclusive of all taxes.
- 5. VALIDITIY OF OFFER: The offer should be valid for acceptance for a period of 180 days from the due date of same.
- 6. **GST:-** The prevailing rates of the GST will be applicable to this order.

- 12. **T&P/MANPOWER**:-All the required Tools, Minor material, Skilled Manpower & T&P required for the job will be in your own scope.
- 13. **PRICE:-** The rates quoted should be firm & price variation will not be applicable at any cost.
- 14. **EXECUTION OF WORK:** In the event of the offer being accepted in the whole, the successful contractor shall execute the order immediately as per the order schedule within the time specified in the work order. The requied T&P is in his own scope for execution of the said work.
- 15. **SECURITY DEPOSIT**:- No any security deposit is applicable being a small value work & work involves only testing.
- 16. **TRANSPORTATION:-** The necessary & required transportation of the materials/labours will have to be done at your own cost. No any transport facility for the material/labour will be provided by MSETCL.

- 20. **PAYMENT**:- 100% payment against the bills for the work actually carried out will be given to you after deducting necessary taxes & duties as per Govt. Rule either by cheque or NEFT/RTGS.
- 21. **PENALTY:** If the work is not completed within the stipulated time period the penalty will be charged as per prevailing rate i.e. ½ % of order value per delayed day maximum upto 10% of the total order value.
