E-Enquiry

To,

Subject: E-Enquiry for Providing of 14/16 seater School bus with Driver, Diesel & Lady Attendant for the student of staff colony for going to school/Collages from staff colony to Dhule city to & fro for education year-2022-23 & for any medical emergency arises in families living in staff colony under 400 kV R.S. Dn. Kundane-Dhule.

Dear Sir,

Sealed and super scribed quotations are invited for the above work as per enclosed schedule 'A'. You are requested to quote your lowest rate for the above work. The terms and conditions are as follows.

General terms & conditions

1. Per day rates quoted should include provision of Rates including Driver's, Diesel & Lady attendant expenses, Oil (Lubricant), day to day maintenance & repairs, Fuel, Oil, RTO payment & all other allied type of expenditure/taxes on vehicle. Nothing shall be paid extra. The rate shall be quoted in words and figures.
2. Bidders should strictly follow norms for facilities & safety measures prescribed by RTO for 14/16 seater School bus & responsibility for same is of bidders only.
3. Your quotation should reach this office on or before **01.05.2022 upto 17:30hrs** and same shall be opened on next day if possible.
4. The enquiry is limited to the period of one year and amounting Limited to **Rs.9,91,200/-** (including all taxes)
5. The work contract tax if applicable will be deducted from your Bill as per rule.
6. The Company will not be responsible for any kind of accident or damages to the vehicle or driver during the hired period. All the financial liabilities arising out of accident shall be borned by the owner of vehicle.
7. The working hours will be normally from 7.00 Hrs to 19.00 Hrs or as per directives of undersigned.
8. Owner should attend any kind of vehicle breakdown. No charges will be paid by MSETCL during breakdown. Agency will have to provide alternate vehicle during breakdown. No charges will be paid by company during breakdown. Agency has to provide alternative vehicle during breakdown.
9. According to financial act, income tax will be deducted from your bill & certificate to that will be issued to you.
10. The rate quoted should be firm & price variation will not be acceptable. Rate should be inclusive of all taxes & other incidental charges.
11. Vehicle owner should manage driver. He should have valid license to drive such type of vehicle and has the minimum 1 years of experience for driving such type of vehicle. Driver should not have any criminal record & NO FIR should be registered on him. Driver should not found with any type of alcoholic drunk during Working hours. The driver shall strictly observe all the provision of M.V. act 1939 amended up to date. The driver must be polite, punctual in attendance & free from illicit habits, throughout the contract period. Driver shall be paid by the agency according to the minimum wages act is the whole responsibility of the agency, MSETCL will not entertain claim/dispute arises for same.
12. Lady Attendant should attend school bus trips in particular uniform dress code throughout contract period.
13. All the rules regarding registrations of vehicle, sales tax, GST tax & other Govt. taxes etc. should be borned by vehicle owner.

14. If it is found that vehicle is not giving satisfactory service, the contract is liable for cancellation after giving 24 Hrs. notice.
15. **Security deposits:** Successful bidder have to pay a security deposit of 5% of the order value for this work with MSETCL in the form of FDR/D.D./BG of any Nationalized/scheduled Bank in the name of 'MSETCL, Dhule', payable at Dhule, valid for one year. The security Deposit to be submitted before starting of work. The security deposit will be refunded only after satisfactory completion of contract.
16. The validity of your work order will be for one complete year from the date of issue of order or Exhaust of order amount from the date of engaging the vehicle.
17. The route is from 400KV Staff colony Kundane-Dhule to various school & colleges in Dhule city in number of trips decided by EE 400KV RS Division, Dhule/AEE 400KV Maint. Dhule. The approximate running may be about **140-150Km**.
18. All terms and conditions as per Company's rules including those work in the M.S.E.T.Co.Ltd. Booklet. "Tender and contract for works" are applicable in this case also. Not with standing stated herein, the Company's general terms and condition of contract shall be applicable to this contract also.
19. Undersigned reserves the right to accept any Tender or to reject/accept all the Tenders without assigning any reason.
20. Any dispute/differences arises, will be subjected to jurisdiction of **Dhule court** only
21. The vehicle owner if, wants any clarification regarding working of vehicle or any terms condition, he should approach in writing to undersigned before quoting the rates.
22. After due date no clarification will be given and the decision of undersigned will be final and binding on all the vehicle owners quoting for said work.
23. The work shall be supervised by the Engineer, appointed by under signed and it should be carried out to the satisfaction of Engineer In charge. In case of any dispute, decision of undersigned shall be final and binding on the contractor.
24. Monthly Bill payment will be paid to you by account payee Cheques in reasonable time and as per the availability of funds after the satisfactory completion of work and as per measurement recorded in SAP-SES.
25. M.S.E.T.Co.Ltd. Ltd. reserves rights to add more terms during the contract period if found necessary.
26. Company's employee /his nearest relatives should not own the said vehicle.
27. After due date no clarification will be given and the decision of undersigned will be final and binding on all the vehicle owners quoting for said work.
28. The undersigned reserves the right to cancel the contract, after giving due notice to you, in the event of breach of contract in any respect or under delay in execution of work.
29. Penalty: - in the event of service not provided /satisfactorily the contractor shall be liable to pay the penalty as ½% per week and maximum of 10% of total value of contract.
30. If the tenderer fails to provide the service it will be treated as breach of contract & contract will be terminated & order will be cancelled and forfeiting the S.D.
31. You should have to execute the agreement on stamp paper of Rs. 500/- at your own cost as per the provision of 'Mumbai Mudrank Adhiniyam 1958, Clause No. 34' with requisite stamp duty immediately after the payment of security deposit. The notary should be done of stamp duty.

Instructions to Tenderer


1. The tenderer duly filled in should be sent in a cover properly sealed and super scribed as shown below in person only to Executive Engineer 400KV RS Division, Dhule so as to reach not later than due date. The cover should be super scribed with name of work and tender No.
2. Only one envelope for tender filled in & for all documents of vehicle such as: -
 - a) Documents of vehicle such as RC/TC book, make, model, seating capacity of vehicle, RTO School bus permit, insurance, PUC certificate, fitness certificate.
 - b) The said vehicle should not be owned by company employee/his nearest relatives. Certificate accordingly should be attached with tender form.
 - c) The vehicle should be in good condition having manufacturing year of preferably 2015 or onwards. if not then relaxation of up to 2 years (i.e. 2013 & onwards) after due physical verification on dt.02.05.2022 by concern S/Dn. Incharge.
 - d) PAN no. copy should be submit.
 - e) Driver's valid driving license to drive such type of vehicle.

f) Proof regarding registration under GST or If not applicable then undertaking regarding that.

3. The tender shall be valid for period of one complete year for academic year 2022-23 from the date of issue of order or Exhaust of Tendered amount from the date of engaging the vehicle.
4. While submitting the tender, the Tenderer must fill in tender form/specification and schedule 'A' of rate. The rate should be quoted both in words & in figures.
5. **Tender Fee: Rs.100/-** will be the tender fees to be paid before or while submitting the quoted bid within due date.
6. The tender documents shall be written legibly and shall be free from eraser, overwriting or conversions of figures correction and where unavoidable corrections in the tender and particularly in rates must be signed and dated by the Tenderer and all pages should bear the initials of the Tenderer at the bottom of each page.
7. The Maharashtra State Electricity Transmission Co. Ltd. or its officer who accepts the tender shall have the right to reject any or all the tenders in part or full and will not be bound to accept the lowest nor to assign any reason what-so-ever for such rejection/acceptance.
8. The Tenderer is supposed to obey all the rules of R.T.O. & M.S.E.T.Co.Ltd. During the course of contract. Failure to obey the rules is liable for termination of contract with all responsibilities with the Tenderer.
9. The tender documents shall be written legibly & shall be free from eraser, overwriting or conversion of figure correction & where unavoidable correction in the tender & particularly in rates must be signed & dated by tender & all pages should bear the initials of tenderer at the bottom of each pages.
10. The submission of tender by tenderer implies that he has read their instructions and conditions of contract & he had made himself aware of scope & specification of work to be done.
