Sealed & Superscribed quotations are invited on firm quotation basis for the works indicated in **Schedule 'A'** so as to reach this office **on or before 09.05.2022 up to 18.00 hrs.** on following Terms & Conditions.

Terms & Conditions:

A) The offer should be submitted in **sealed envelope** containing following documents as well as price bid superscribing the subject.

1. Proof of valid registration of firm under Bombay shop & Establishment Act.
2. GST registration certificate
3. Photo copy of PAN No. of bidder
4. Valid workman compensation policy
5. The Bidder should have executed similar work in MSETCL, which should not be less than 60% of estimated amount. The bidder should submit the work experience certificate issued by the officer not below the rank of Executive Engineer along with the detailed work order.

B) **Quotations with incomplete details submitted without sealing or superscribing not submitted in prescribed format etc. are liable to reject.** Offer on Fax or E-mail will not be accepted. This office will not be responsible for delay in postal transit. **The agency should not submit 'conditional quotation' such conditional offer shall be liable for rejection.**

1. Name of Work: - Work of preliminary, detailed & check survey of EHV lines under the jurisdiction of EHV O&M Dn-II, Pune as & when required.

2. Contract value: The value of contract is **limited to Rs. 5,00,000/- (Including GST).**

3. Security Deposit:- Bidder has to submit Security Deposit @ 5% of the total value of the work order.

4. Agreement:- Bidder has to execute an agreement on Rs.500/- Bond paper & cost of agreement to be borne by the agency.

5. Operating officer: The Addl. Executive Engineer, Line Maintenance S/Dn-II, Pune is appointed as operating officer.

6. Scope of work: - The scope of work against this contract is as detailed in Schedule 'A'. The survey work includes any alterations/modification/ inline shifting/diversions in case of existing line under jurisdiction of this division.

The work should be carried out as per the instructions of operating officer. The survey is to be done as per the standardized practice and in existing ROW of EHV lines. NA plots must be got checked from Tahsildar/Talathi etc. and avoided Railway/ Power/ Telephone line crossings must adhere to set norms, if any. Vertical and horizontal clearances wherever necessary must be taken. The survey is to be done in consultation with the Engineer-In-Charge.

7. Validity of work: - Validity is up to 12 months from the date of issue of work order.

8. Work completion period: You will be given a call for each assignment & you will have to complete the work with submission of report within 7 to 15 days time which will be specified in the call.

9. Penalty: - If bidder fails to carry out the work within stipulated time as mentioned above, will be liable to pay penalty at the rate $\frac{1}{2}\%$ per day of order value subject to maximum 10% of the total value of the order.

10. Labour & T&P for the works will be on bidder's account. Required man power and machinery should be arranged by bidder.

11. Site Visit: - The Bidder is advised to visit & examine the site of work & its surrounding & obtain for himself, on his responsibility, all the information that may be necessary for preparing the bid & entering in to the contract. The cost of visiting the site shall be at bidder's own expense.

12. Drawings/Map:- These should be as per required for completion of detail survey for the attended lines. Data on the route alignment and ground profile shall be prepared by the bidder.

13. Mistakes in drawings/Map:- The Contractor shall be responsible for any discrepancies, errors or omissions in the drawings/map or other particulars supplied by him and shall pay all the costs of the alterations in the work necessitated thereby.

14. Payment of Bill: Payment to be released against completion of work.

A) Bill in triplicate along with guarantee certificate and advance stamp receipt shall be submitted to EE EHV O&M Div. II, Pune.

B) Payment will be made within reasonable time by EE/EHV O&M Div. II, Pune on actual measurement basis. After receipt of duly certified and recorded bill by concerned operating officer and after taking necessary entries in ERP-SAP system.

15. Taxes and Duties: *Taxes will be applicable as per prevailing rate. Statutory deduction shall be made as per applicable.*

16. Validity period of offer should be not less than 120 days from the date of submission of offer.

17. The right to place an order for part or to cancel any or all quotations without assigning any reasons is reserved with this office.

18. Validity period of offer should be not less than 120 days from the date of submission of offer.

19. The rates quoted should be including transportation charges, labour charges, material charges & all taxes and charges.

20. The bidder should be fully aware of the M.S.E.T. Co. Ltd. General Condition for execution of work and same is applicable to this contract also. Any of the condition will not exempt you from your liability to be abiding by the same.

21. All disputes or differences arising under, out of or in connection with this contract, if concluded, shall be subject to exclusive jurisdiction of PUNE Court only.
