The Other Terms & Conditions are as follows:


1. Scope of work: Cutting of grass shrubs, thorny bushes from roots or trimming, within the corridor of 35 mtr for 220KV Line & 27mtr of 132KV Line as per directives of Addl. Executive Engineer, Line Maint. Sub-division Parbhani. Removed trees, branches, bushes, should be removed & dumped away as directed by field officer.
2. Quotations should be duly filled in all respect & sealed envelope to be submitted to this office, within due date.
3. Rate shall be quoted, in Schedule-A. The rate quoted shall be valid for 120 days from the date of opening the quotations.
4. GST, Duties, Taxes, Cess, Royalties etc will be recovered from bill, as applicable.
5. Enclose duly attested & signed copies of following valid documents, along with quotations:
  - A. Proof of Registration of firm under Bombay Shop & Establishment Act / SSI Certificate / Certificate under Company's Act.
  - B. Proof of Valid Electrical Contractor License
  - C. Proof of GST Registration
  - D. Valid Workman Compensation Policy
  - E. Undertaking for Submission of Labors Contract License if work is allotted and more than prescribed number of employees are employed by agency
  - F. Income Tax Returns for last years with PAN Card Copy
  - G. Experience certificate from the officer not below the rank of Executive Engineer for having successfully executed the work of Tree cutting under EHV lines during last 7.
  - H. Duly signed Annexure-A with declaration from contractor.
