Sealed and super scribed quotations are invited for the above work as per enclosed schedule 'A'. You are requested to quote your lowest rate for the above work. The terms and conditions are as follows.

## **TERMS AND CONDITIONS:**

- 1. Your quotation should reach this office <u>on or before date 27.05.2022 by 17:30 Hrs.</u> and same shall be opened at 11.00Hrs. on next office day, if possible.
- 2. <u>Rates</u>: Rates shall be quoted on firm quotation basis inclusive of all other charges, taxes, Except GST tax etc. The rate shall be quoted in words and figures.
- 3. **Document Required:** The rate offer must be accompanied with the following documents duly attested & signed by vender
  - a. Proof of registration of firm under Bombay shop & Establishment Act.
  - b. The firm should be registered with P.F., If not applicable then undertaking for it.
  - c. PAN NO. & Income Tax return certificate for last three years.
  - d. GST Tax Registration Certificate, If not applicable then Certificate of annual turnover.
- 4. <u>Taxes</u>: The taxes will be deducted as per provision of ACT & work contract tax if applicable will be deducted from your Bill as per rule. Any other deduction if required under any Finance acts shall also be made from contractor's bills, unless he produces necessary exemption certificate.
- 5. If any damage occurs to the company's property during execution of above work, contractor will have to make them good at his cost.
- 6. <u>Security deposits</u>: The You have to pay a security deposit of 5% of the order value for this work with MSETCL in the form of FDR/D.D./BG of any Nationalized/scheduled Bank in the name of Executive Engineer of 400KV R.S O&M Div. The submission of the tender by the tenderer implies that he has read all instructions, the conditions of the contract etc. and has made himself aware of the scope of the rates and local conditions and other factors bearing on the execution of the contract and the company shall not be liable to pay any extra charges for any reasons whatsoever in case the contractor is found later on to have misjudged by himself.
- 13. MSETCL reserve rights to add more terms during the contract period if found necessary.
- 14. The work shall be supervised by the Engineer, appointed by under signed and it should be carried out to the satisfaction of Engineer In charge. In case of any dispute, decision of undersigned shall be final and binding on the contractor.
- 15. You shall be responsible for Cleaning & Sweeping and cleaning of toilet, WC pan, Urinal pan at 400KV Control room & offices under 400 KV RS & 220KV SS Premises. Any lapse in this respect shall be recoverable from your bill for which company will incur any expenditure.
- 16. If any of the services mentioned in the schedule 'A' are not carried out on any particular day by you, the payment of respective day will be deducted from your Monthly Bill. Also fine of Rs. 100 per day shall be levied.
- 17. **Payment:** Monthly Bill payment will be paid to you by account payee Cheque in reasonable time and as per the availability of funds after the satisfactory completion of work and as per Service period recorded in ERP-SAP SES.
