Technical & Financial Qualifying Criteria for the Bidder

Tenderer should upload the following digitally scan copies of original documents / certificates online under technical bid.

- 1) **Turnover:** Average Annual financial turnover certified by chartered accountant, during the last 3 years duly tallied with profit and loss account of corresponding years. Ending 31st March of previous financial years. Should be at least 50 % of the estimated cost. The bidder should have to produce certificate duly certified by Chartered Accountant in the Performa given in Annexure- VIII
- 2) **Work order copies and Exp. Certificate** for Annual contract of unloading of Power transformer & its accessories being received within the jurisdiction of Major Store 'A' Wardha for the year 2022-23. **Experience of having successfully completed similar works amounting to 60% of the estimated cost in maximum 3 orders** during last 5 years ending last day of month previous to the one in which applications are invited.
- 3) Current valid copy of **GST** Registration
- 4) Professional Tax Certificate
- 5) Current valid copy of registration under Shops and Establishment Act/SSI/NSIC.
- 6) Proof of registration under PF act
- 7) Valid electrical contractor license.
- 8) Income Tax Returns of last 03 years & Pan Card copy, audited balance sheet, profit and loss account.
- 9) Detail of T&P required for the said work.
- 10) Proof for tender fee
