5. The rate quoted will be inclusive of labour cess and exclusive of GST.
6. GST, Duties, Taxes, Cess, Royalties etc will be recovered from bill, as applicable.
7. Enclose duly attested & signed copies of following valid documents, along with quotations:
  - a. Proof of Registration of firm under Bombay shop & Establishment Act/ SSI Certificate /Certificate under Company's Act.
  - b. Proof of valid Electrical Contractor License.
  - c. Proof of GST Registration.
  - d. Income Tax Returns for last years with PAN Card Copy.
  - e. Experience certificate from the officer not blow the rank of Executive Engineer for having successfully executed similar type of work in last 5 year in MSETCL.
  - f. Duly signed Annexure-A with declaration from contractor.
8. The envelope containing quotation should be properly sealed & subscribed Quotation for :

**“work of supply & installation of Oil Reconditioning Unit ORU for substation maintenance subdivision, Aurangabad under EHV O&M Division A'bad.”**


9. No extra charges will be paid for Vehicle driver, fuel, T&P, other taxes & duties etc.


