Technical Bid.

- The bidder' should have completed work order(s) & its experience certificate of successfully completed similar works at any HVDC Terminal station in India.
- The performance/experience certificate shall be issued by the officer not below the rank of Ex. Engineer. The bidder shall also submit the copy of the supply order mentioned in the experience certificate.

Commercial Bid.

- PAN Card of the firm / proprietor as the case may be.
- Income Tax Return for F.Y 2020-21.
- List of T&P available with the agency for execution of the work.
- Certificate of Registration for GST with latest paid Challan. (if applicable)
- Turnover duly certified by Chartered Accountant should not be less than 60% of the estimated cost during the F.Y 2020 21. Certificate issued by Chartered Accountant must have 15 digit UDIN (Unique Document Identification Number) if issued on or after 01.04.2018.
- Net Worth of last Financial Year 2020-21 duly certified by Chartered Accountant (with UDIN) should not be less than 25% of estimated cost.
- Valid Govt. Electrical contractor license.
- Shop Act License.

- 3. The Contractor rates should be in percentage (%) based on estimate cost.
- 4. Rates should be valid for 120 days from the date of commercial opening of RFx.
- 5. Rfx fee is Rs.118/- including taxes (Is non refundable).
- 6. If the above documents are not applicable then submit Eligible/ Non eligible documents list.
- 7. Income Tax will be deducted from contractor's bill, as per Govt. rules.
- 8. **Warranty**: 'The Contractor' will have to give a warranty / guarantee for material supplied for the period as specified by the manufacturer/OEM of the material from the date of receipt of material at site / work place as the case may be. The warranty certificate should be given along with the material. If the OEM warranty is less than One year the bidder shall give warranty of at least one year from the supply of material.
- 9. Rates should be exclusive of all taxes or all applicable taxes and their charges should be mentioned separately and clearly in percentage.

 - ➤ One No. of bushing (3A) was damaged and same needs to replace with available spare bushing.
 - ➤ Oil leakage from the turret of bushing (3B), for attending the oil leakage gasket need to replace for which bushing need to dismantle and re-erected.
 - > Draining, filter and refilling of T/F oil (Draining and Vacuum oil filling and filtration.
 - > Dry air filling during oil draining/dismantling/erection activity and attaining of other minor leakages.
