- 1) The **Rates [Item Rate]** should be quoted on Firm Quotation basis (Two Bid System only) including cost of Materials, Transit Cost and T&P [If Any] etc. required for execution of the work.

    - (i) Valid Certificate of Registration of Registration under Maharashtra Shops and Establishments Act & having registered as vendor in MAHATRANSCO with valid GST/ GSTIN Registration Certificate.

- 4) The work should be strictly carried out as per standard specifications stated in W.O. & up to the entire satisfaction of the Engineer-in-charge.
- 5) No materials will be supplied by the MSETCL for this work except materials as shown in Schedule B
- 6) Payment will be made through First & Final bill/R.A. bill basis at the discretion of undersigned.
