Please offer reasonable rates for the above subject work as per the enclosed schedule 'A'. The detailed scopes of works are given below. Please note the following.

TERMS & CONDITIONS:-

- 1) **DUE DATE:** The quotation complete in all respect, duly sealed & super scribed should be submitted to this office on or before **Dt. – 20.06.2022** up to **15:00** Hrs Positively.
- 2) **SCOPE OF WORK:** Work of Anti-termite, Anti-reptile & Anti-rodent control Treatment (Includes Anti mosquito, Anti, Lizard, Anti Cockroach & Snake Control treatment) for the premises under 400 kV RS Division Khadka- Bhusawal.
- 3) **QUOTED RATES:** The rates quoted are including of all taxes, charges, etc.
- 4) **ENQUIRY FEES:** - Agency should have to pay Rs. 100 against enquiry quotation Fees by cash to this office & copy of receipt attached with quotation.
- 5) **SECURITY DEPOSIT:** The successful Contractor(s) will have to submit **Security Deposit** at the rate of **5 %** of the value of the LOI by cash /Demand Draft / Fixed Deposit / Bank Guarantee at the office of the Executive Engineer, 400kv Rs Dn. Khadka, Bhusawal within 15 working days from the date of receipt of letter of intimation. The detail order will be issued only after the payment of security deposit.
 - a. The Demand Draft / Fixed Deposit / Bank Guarantee submitted towards the Security Deposit shall be in the name of the Executive Engineer, 400kv R.S. Dn. Khadka, Bhusawal.
 - b. The Bank Guarantee shall be on a Scheduled Bank / Nationalized Bank and it shall be valid entire the whole period of completion of work.
 - c. If the successful Contractor fails to submit Security Deposit within the stipulated period, it will be presumed that the Contractor is not interested in execution of the contract and the work contract will be issued to other agency (i.e.). The decision of E-enquiry accepting authority i.e. the Executive Engineer, 400 kV R.S. Dn. Khadka, Bhusawal shall be final and remain binding on the Contractor(s).
 - d. No interest will be paid on the Security Deposit and the Security Deposit will be refunded after satisfactory execution of works.

6) AGREEMENT & STAMP DUTY:-

- a. The successful Contractor has to execute an Agreement with The Executive Engineer, 400kV RS Dn. Khadka, Bhusawal within 15 working days after receipt of letter of intimation; the work order will be only issued after executing the Agreement & submission of security deposit @ 5 % to this office.
- b. The successful Contractor shall submit an Agreement Bond on Rs.500/- non-judicial stamp paper as per the Clause 63 of Mumbai Stamp Duty Act 1958. The expenses towards the stamp paper and preparation of Agreement Bond will be on the part of the contractor.

7) VALIDITY OF OFFER: The offer should be valid up to the exhausting of work order value from the opening of the quotation.

8) SUPERVISION OF THE WORK: - The work shall be under the overall supervision of the Executive Engineer or his representative. In case of any dispute, decision of undersigned shall be final and binding on the Contractor. The work should be carried out as per the directives of the concerned incharge or his representative.

9) WORK COMPLETION PERIOD:- The period of completion of entire work is for one year from the date of site handed over from concern incharge. The work for every quarter/month shall be completed from the date of intimation or handing over of site. However In no case the program laid down should be delayed. Failing to which it shall amount to delay & liable for penalty. You will have to complete the work as per instructions from concerned incharge & you will have to take all the safety precautions for these works. And also you should take care to employ sufficient skilled manpower along with sufficient safety precautions for completion and the work well within the stipulated time period.

10) SUBMISSION OF BILL & PAYMENT:- You will have to submit the Original bills quarterly in triplicate including work order No., Pan No., GST No. along with satisfactory detail work completion report which will be signed with concern unit incharge to this division in the name & office of the undersigned. The same will be submitted to the concerned unit for further process. After that the concern Incharge will verify & certify the bill as per MSETCL standard procedure & submit the same to this office for effecting payment. After due audit & verification, Executive Engineer, 400 kV RS Khadka-Bhusawal, shall effect the payment. Payment of Bill will be made as per the availability of funds at 400 kV RS Khadka-BSL. However, the payment will be made as per actual measurement & as per the actual work done.

11) DOCUMENTS REQUIRED TO BE ATTACHED ALONG WITH OFFER:-

Following are the list of qualifying documents required please attached for qualifying in the Techno-Commercial Bids for opening of the price Bids. (If yes please attach the following documents)

- I) Valid License/Letter to Sell, Stock OR Exhibit for Sale OR Distribution of Insecticides for the Purpose of Pest Control from Agriculture Officer of Agriculture Department, GOM.
- II) Valid registration under GST if applicable otherwise submits the undertaking.
- III) PAN card copy.
- IV) The bidder should have to submit the Work completion/experience certificate of similar type of subjected works issued by authority not below the rank of Executive Engineer or equivalent in Govt. /Semi- Govt. Utilities as a proof of experience.

If validity of any license/certificate expires during order period, you will have to renew the same & submit the copy to this office. Payment will be affected for valid period only.

- 12) **QUALITY OF MATERIAL:** Bidder will be responsible for quality of material & workmanship. The material to be supplied will be strictly as per specification as per Schedule.
- 13) **TOOLS & PLANTS:** - You will have to arrange all tools, plants, manpower, material, Safety equipments/T&P etc. to carry out the work successfully at your own cost. You will have to provide all safety measures to your staffs while executing the work in sub-station.
- 14) **SAFETY:** - The contractor shall ensure the safety of all the workmen, materials and equipment either belonging to him or to other working at site. The contractor shall be responsible for providing of all safety notices and safety equipment required. If any accident occurs during the work, the complete responsibility of the accident will be of Contractors. The M.S.E.T.C.Ltd. Shall not pay any type of compensation for any type of Accident.
- 15) **LIQUIDATED DAMAGES/ PENALTY FOR DELAY:-**The work should be completed within stipulated time period and completed as per directives of operating officer/Engineer in charge, failing to which the penalty will be Charged at the rate of @ 0.50% (half – percent) per week of delay. The total amount of penalty charge will be subject to maximum of 10% of the ordered value for entire scope of work. If you fail to complete all the work within the time frame, the MSETCL shall levy liquidated damages for breach of contract. And In case of delay, the contract may be terminated by the competent authority as per general rules & regulations of MSETCL & balance work shall be got completed through separate contract at your risk & cost.
- 16) **T.D.S., GST, LABOUR CESS & APPLICABLE TAXES:-** The T.D.S. at source as per prevailing rates & rules or at the rate amended from time to time in accordance with the provision of financial act, GST as per Govt. Rules of taxes as applicable, Labour Cess @1% under the Building & other construction workers welfare cess act 1996 & Applicable taxes will be deducted from your bill.
- 17) **APPLICABILITY OF GENERAL CONDITIONS OF CONTRACT:-** The Works/Materials should be carrying out as per the standard practices of MSETCL & the terms & conditions stipulated in the Enquiry will also a part of the contract & will be binding on you wherever it is not specifically mentioned. MSETCL reserve the right to add more terms & conditions during the contract period if found necessary. Notwithstanding anything stated here, the Board's General Terms & conditions of contract shall also be applicable to this contract.
- 18) **CONTRACTOR'S DEFAULT:-**
- In case you fail to complete work fully OR partly, the security deposit will be revoked by MSETCL. In this case the balance work will be got done from other agency may be at higher rates and the difference in cost will be recovered from the contractor's bills.
 - In case of any loss / damage to the Owner's asset /material, it will be the sole responsibility of the contractor to lodge the complaint in writing to the nearest police station under intimation to this office or to In-charge/ designated officer.
 - If there happens any loss of goods or damage to valuable material in the premises on account of negligence of the Staff, the cost of loss / damage shall be recovered from the contractor.
- 19) **ACCIDENT:** If any accident occurs to the labour skilled or unskilled, compensation if any is to be paid by the bidder at his cost.

20) DAMAGE TO PERSONS AND PROPERTY: - Contractor will indemnify the MSETCL against any losses and claims regarding any injuries or damage to any person, material or physically damage any property whatsoever which may arise out of or in consequence of the execution of work. During execution of work any damage/loss to Transmission Company's property occurs will be recovered from your bill.

The right to add/alter/modify/order partly or fully at any stage or to cancel without assigning any reason thereof is reserved by the undersigned.

21) The undersigned reserved the rights for cancellation of any or all quotations without assigning any reason.

22) JURISDICTION: - All disputes or difference arising out of and in connection with the Contract shall be subject to the exclusive jurisdiction of Bhusawal Court only.

23) MSETCL Reserve rights to add more terms during the contract period if found necessary. The right to add/alter/modify/ order partly or fully at any stage or to cancel without assigning any reason thereof is reserved by the undersigned.
