- 2. Document should upload the following digitally signed scan copies of documents /certificates online under

Technical Bid.

- Submit the performance /experience certificate for similar nature of work.
- The performance/experience certificate shall be issued by the officer not below the rank of Ex. Engineer. The bidder shall also submit the copy of the work order mentioned in the experience certificate.

Commercial Bid.

- PAN Card
- GST Registration
- Income Tax return for last one year
- Shop Act License.
- Annual Turnover for last 1 year duly certified by Chartered Accountant should not less than 60% of the estimated cost.
- Net Worth of last 1 year duly certified by Chartered Accountant should not be less than 20% of estimated cost.
- 3. The Contractor rates should be in percentage (%) based on estimate cost.
- 4. Rates should be valid for 120 days from the date of commercial opening of RFx.

5. Rfx fee is Rs.118/- including taxes (Is non refundable).

6. If the above documents are not applicable then submit Eligible/ Non eligible documents list.

7. Income Tax will be deducted from contractor's bill, as per Govt. rules

8. Rates should be exclusive of all taxes or all applicable taxes and their charges should be

mentioned separately and clearly in percentage.

deposit.
