- 1) **Due Date:** The quotations complete in all respects should be submitted online on or before 21.06.2022; 13:00 Hrs. positively.
- 2) **Scope of Work:** Purchase of 04 Nos. 25 kg SF6 gas cylinders under EHV (O&M) Circle, Khadka-Bhusawal as per Schedule "A".
- 3) The supply of SF6 gas should comply with Standards:
 - a) SF6 Gas: SF6 (Sulphur Hexafluoride) gas shall conform to EEC: 60376 and IS 13072.
 - b) Gas Cylinder: SF6 Gas cylinders shall conform to the relevant standard.
 - c) Cylinder valves: The valves fitted to the cylinders shall conform to ANSI: B57.1 or BS:341 Part I or IS: 3224.
- 4) **Quoted Rates:** The rates quoted are including of all taxes, charges, etc.
- 5) **Security Deposit:** The successful bidder will have to pay an amount equivalent to 5% of Contract value towards S.D. at SE EHV (O&M) Circle, Bhusawal within 7 days from the date of receipt of LOI which is refundable after satisfactorily completion of guaranty period.
- 6) **Agreement:** Agreement contract between MSETCL & successful bidder should be carried out on Rs. 500/- bond paper within 7 days from the date receipt LOI. Successful bidder will have to borne the charges for agreement bond.

- 7) **Validity of Offer:** The offer should be valid for our acceptance for a period of 6 month from the due date of this enquiry.
- 8) **Delivery Period:** 04 Nos. 25 kg SF6 gas cylinders should be delivered within 30 days from the date of work order at Major Store, Dhule.
