- 1) **Due Date:** The quotations complete in all respects should be submitted online on or before 04.08.2022; 13:00 Hrs. positively.
- 2) **Scope of Work:** Procurement of 33 kV PT for the tertiary side delta formation of 400/220 kV ICT 's at 400 kV R.S. (O&M) Division, Khadka, Dhule & Deepnagar Bhusawal-II as per Schedule "A".
- 3) Specification as mention in the Annexure-A.
- 4) **Quoted Rates:** The rates quoted are including of all taxes, charges, etc.
- 5) **Security Deposit:** The successful bidder will have to pay an amount equivalent to 10% of Contract value towards S.D. at SE EHV (O&M) Circle, Bhusawal within 7 days from the date of receipt of LOI which is refundable after satisfactorily completion of guaranty period.
- 6) **Agreement:** - Agreement contract between MSETCL & successful bidder should be carried out on Rs. 500/- bond paper within 7 days from the date receipt LOI. Successful bidder will have to borne the charges for agreement bond.
- 7) **Validity of Offer:** The offer should be valid for our acceptance for a period of 180 days from the due date of this SRM E-Enquiry.

- 8) **Delivery Period:** PT for the tertiary side delta formation should be delivered within 90 days from the date of work order at Major Store, Dhule.
- 9) **Technical Qualifying Criteria:** The rate offer must be accompanied with following documents by vendor:

**Technical bid (Qualifying Requirement):** Bidder should upload the following digitally scan copies of original documents / certificates online in 'note & attachments' tab in RFx.

**1. Statutory Qualifying Requirement/Criteria:**

- i. The Bidder should have a valid registration under Bombay shop & Establishment Act 1948/ Small Scale Industry Act / Company(Factory) Act - Proof thereof
- ii. The Bidder should be Register under Goods & Services Tax (GST) Act – Proof thereof.

**Note: The original colored scan copy should be uploaded as bid documents in support of statutory qualifying criteria i.e. statutory licenses/registration. The attested / notarized photo copies of the same will not be entertained.**

**2. Technical Qualifying Requirement/Criteria:**

- i. The bidder either manufacturer or authorized dealer/channel partner of manufacturer. If the bidder is authorized dealer/channel partner, then valid authorization letter from manufacturer should be uploaded for this SRM E-Enquiry.
- ii. The bidder should have in last 05 years experience of " Similar work i.e. supply of material tendered of equal or higher voltage class for amounting as follows;
  - a. **One** completed work mentioned above having costing not less than the amount equal to **70%** of the estimated amount, OR
  - b. **Two** completed works mentioned above having each costing not less than the amount equal to **40%** of the estimated amount, OR
  - c. **Three** completed works mentioned above having each costing not less than the amount equal to **30%** of the estimated amount.
- iii. The bidder or his manufacturer should have proven experience not less than 5 years in Design, manufacture, supply, and testing of similar equipment/ material tendered of equal or higher voltage class.
- iv. The Bidders or his manufacturer should have adequate in-house testing facilities for conducting all the acceptance test in accordance with relevant IS also submit valid latest type test report.
- v. The bidder should submit the end user's Certificate for successful operation of material at least for 2 years as on the date of submission issued by the authority not below the rank of Executive Engineer or Equivalent with detail work order copy.
- vi. The owner reserved the rights to accept / reject the Bid.

**Note: The original colored scan copy should be uploaded as bid documents in support of Technical qualifying criteria. The attested / notarized photo copies of the same will not be entertained. Detailed communication address, e-mail ID and contact nos of the end users should be furnished for cross verification.**

**3. Financial Qualifying Requirement/Criteria:**

- i. The Average Annual turnover of the bidder during last 3 financial years should be not below than 60% of estimated cost.

The bidder should submit the certificate of turnover through Unique Document Identification Number (UDIN) duly certified by Practicing Chartered Accountant for preceding (last) 03 financial years on the basis of audited financial statement

- ii. The bidder should have a “**Net Worth**” (which is defined as “Equity share capital + Reserves – Revaluation reserves – Intangible assets – Miscellaneous expenditure to the extent not written off and carry forward losses”) of not less than 25% (Twenty Five percent ) value of estimated cost of tender offered. The bidder should submit the statement of Net Worth duly certified by Chartered Accountant for the last financial year.

The bidder should submit the statement of Net Worth through Unique Document Identification Number (UDIN) duly certified by the Practicing Chartered Accountant.

**OR**

The bidder should have submitted the Solvency certificate of 25% of the estimated cost from any scheduled or Nationalized Bank. Also the certificate should not be older than last 06 months from the date of bid submission.

- iii. Copy of PAN Card, IT returns, Audited Profit & Loss statement and Balance Sheet for 3 Financial Years.

**Note: The original colored scan copy should be uploaded as bid documents in support of Financial qualifying criteria. The attested / notarized photo copies of the same will not be entertained. The duly audited, verified and certified figures from chartered accountant will be considered for annual turn over and net worth. The provisional certificates( if any) will be not be entertained.**

#### **4. Other Mandatory Documents For Valid Bid:**

- i. The bidder should complied/meet MSETCL’s required technical specifications mentioned in Annexure-“A”. The manufacturing of the equipment shall be strictly in accordance with the requirements of technical specification.
- ii. One set of documents incorporating the following particulars shall be included in the online offer- GTP, BOM, Drawings, Technical literature/ Manual for the offered equipment.
- iii. The bidder or his manufacturer should have well established, prompt after sales service-support facility/network in India. Necessary documentary evidence should be submitted along with the bid.
- iv. The price variation (PV) clause is not applicable for this SRM E-Enquiry.
- v. EARNEST MONEY DEPOSIT (EMD): online Mode only

The bidder should have to submit the proof regarding payment of SRM E-Enquiry fee & E.M.D. @1% of estimated cost.

The bidder shall pay the Earnest Money Deposit as set below along with the SRM E-Enquiry. The SRM E-Enquiry without the payment of Earnest Money Deposit shall be summarily rejected.

- a. Unless the bidder is exempted on account of statutory directives as enlisted in clause (b) below. Earnest Money Deposit should be @1% of the estimated value of the SRM E-Enquiry or Rs. 5000/- whichever is more.

- 1) All Government and semi Government Institutions under Government of Maharashtra and Zilla Parishad in Maharashtra and fully owned undertaking of any State Government and Government of India ( for the item's manufactured by such institutions / units).
- 2) Small-scale industrial unit permanently registered with Directorate of Industries Maharashtra for the manufactured items.
- 3) Small scale industrial unit registered with National Small Industries Corporation (NSIC) and Small Industries Services, Institute of Govt. Of India for the manufactured items.

The benefits mentioned in '1' to '3' above shall be available only to those items approved during the Registration process and subsequent updates in registration upto the date of submission of this SRM E-Enquiry.

No interest shall be paid on the Earnest Money Deposit.

- c.** In the event the bidder withdraws his offer during the validity period the earnest money deposit shall stand forfeited and the Purchaser shall be entitled to recover the amount of E.M.D. paid or encashing the Bank guarantee or by resorting any other remedy available under the law.

**Note for SSI unit :** The bidder registered with Directorate of Industries of Government of Maharashtra for manufacturing the items tendered/offered and those who have attached valid Certificate at the time of vendor registration shall be considered for concessions applicable. These benefits shall be available only to those items approved during the Registration process and subsequent updates in registration up to the submission of this SRM E-Enquiry.

**EMD REFUND:** Earnest money deposited (EMD) will be refunded online through SRM System after approval from competent Authority. EMD will be credited to the bank account maintained by bidder in vendor Profile in SRM system. Bidders are requested to ensure that the bank details i.e. Account No., IFSC Code, Account Holder Name, Bank Name, Bank Address are correctly maintained in SRM System and update the same, if required.

It may be noted that:

1. In case bank details are not maintained by the bidders in their SRM Vendor profile, EMD will not be refunded online and MSETCL will not be responsible for the delay.
2. MSETCL will not be responsible for any financial implications in case incorrect bank details are maintained by the bidders as it is the sole liability of the bidder to maintain correct bank details to facilitate online refund of EMD."

If it is revealed that the participating Bidder is Debarred/Blacklisted by Any Government/Semi-Government/Other Power Utility, anywhere, the Offer of such Bidder shall be liable for rejection at any stage of SRM E-Enquiry process.

Further, it is revealed that the successful Bidder is Debarred/Blacklisted by any Government/Semi-Government/Other Power Utility, anywhere then Order of such Bidder shall be liable for termination at any stage of Order execution process and the concern Bidder shall be solely responsible for the consequences arising there from.

**5. The documents attached by the bidders in SRM E-Enquiry shall be clearly visible.**

6. Even though the bidders meet above qualifying criteria, as per their statements they are subject to be disqualified if they have.

  - b) Record of poor performance such as poor quality of product, not properly completing the contract, inordinate delays in supply completion,
  - c) Financial shortcomings or any failures in past contracts.
  - d) Insufficient experience, or employing insufficient number of employees, or not employing the qualified employees
