- 4. Quotations should be duly filled in all respect and signed, failing which it will be liable for rejection.
- 5. In case of any dispute, decision of the undersigned shall be final and binding on the contractor.
- 6. Taxes should be quoted distinctly, if any.
- 7. First & final bill should be submitted to this office after satisfactory completion of the supply, for arranging payment.
