Application for extension in time limit will have to be made in advance.
2. The work should be carried out as directed by the authorized representative of the office to the full satisfaction. The work is to be carried under this office only.
3. Quantities mentioned in Schedule - 'A' is approximate and are liable for variations. However, payment shall be made as per actual quantity executed and measured as per MSETCL's rules.
4. **DUE DATE: -** Last date of submission is on or before 11.08.2022 up to 13:00 hrs.
5. **VALIDITY OF OFFER: -** The offer should be valid for our acceptance for a period of 60 days from the due date of opening.
