- a) Valid Shop Act License b)Pan Card c)RTO vehicle Registration, d)Valid Tourist Permit e) Valid Insurance f)Valid PUC certificate g) Driver licensee Xerox h) Fitness Certificate i) Road Tax paid receipt recent year
- 5. Mandatory Terms & Conditions
 - a) The minimum of 1800 Km/ month will have to be borne by vendor including (Hiring Charges +Fuel +Driver) in rate quoted at sr. no. 1 in Schedule 'A' above.
 - b) The Km run above 1800 km in month will be considered as extra Km and charges will be paid accordingly as per sr. no. 2 in Schedule 'A' above.
 - c) The vehicle must comply with working A/C at all times during duty Hrs.

- d) The major/minor repairs & drivers expenditure will be borne by the owner. Also the Consumable/ wearable items such as wind shield wipers/tyres/break pads must be maintained.
- e) The Toll tax/Parking charges will be borne by MSETCL. The appropriate amount is to be maintain in your fast tag account and same will be reimbursed to you on submission of documentation
- f) In Case of vehicle not available/ In Transit breakdown a penalty of Rs. 1000/- in addition to substitute vehicle that must be provided by Agency at its own cost.
