Terms and Conditions:-

1. **Qualifying Conditions :-** Contractor should have following documents ,a copy of which should be submitted along with quotation .
 - a) Proof of GST Registration
 - b) Proof of Registration under Bombay Shop and Establishment Act /SSI/MSME
 - c) Bidder should submit valid Electrical Contractor license
 - d) Copy of PAN Card and ITR for last 3 years .
 - e) The bidder should have experience of similar type of works at 400KV/220KV Substations in MSETCL /PGCIL/Government/Semi-Government and he must submit the experience certificate and order copies for the same. The experience certificate from the authority of the rank of EE or above in MSETCL or equivalent shall be submitted.
2. **Scope Of Work:-** Detail Scope of Supply is enclosed along with Schedule 'B' and the rates should be filled up for the particulars of supply in Schedule 'B'.
3. **Engineer In Charge :-** The Add.Exe Engineer maint. 400KV Switching S/S or his authorized representative will be the Engineer In Charge.
4. The contractor will have to deposit an amount equal to 5% of the total work order value , if work is awarded to him as security deposit in cash/NEFT/RTGS/ DD/B.G/. The same will be refunded only after satisfactory completion of guarantee/warranty period of 12 months from the date of supply.
5. The rate quoted by you shall be inclusive of all taxes, royalties, octroi service tax etc.& nothing extra shall be payable. The rate should be quoted clearly in words and figure in ink .Scratched and over written rates / offer if any shall not be considered unless corrected with initials.
6. Necessary arrangement for transportation of the material has to be made by the contractor while transporting the materials.
7. **Time Limit:** - The overall time allowed for supply of material covered under this contract shall be 15 days from the date of issue of order/LOI . The contractor will have to execute and complete the work under contract strictly in accordance with the work time bound programme .
8. **Penalty:-** If the contractor fails to execute the work as per the scope of work within stipulated period as above penalty towards delay @ ½ % per week maximum to the extent of 10% of order value will be levied and deducted from bill for non execution of the work.
9. **Payment:** - The Contractor will have to submit the Bill to the Division office for the work executed by him. The payment of Bill will be released depending on the fund position in reasonable period as per the terms and conditions of Contract. No claims for payment of interest / damurage etc. for any delay in the payment shall not be considered or payable by the M.S.E.T.C.L.
10. The income tax as per prevailing rules & labour cess@1%/GST TDS as per the rule will be deducted from the bills.
11. **Tools & Tackles:** - All the required tools & tackles along with Machineries for the replacement of equipments will be in the scope of agency

12. Payment to his workers:- The contractor will have to pay wages as per minimum wages act to his workers as specified by the Commissioner of Labour.
Laws & Regulations:-This contract is governed by various labour Laws & Regulations and amendments made therein from time to time.
I] Workmen's Compensation Act.
II] Shop & Establishment Act.
III] Payment of minimum wages Act.
IV] Contract Labour-Regulation & Abolition Act.
V] Industrial Dispute Act.
VI] CPF Act/Regulation and any other Labour Law and Rules as applicable time to time.
13. Accident Responsibility & Compensation: - If any accident occurs to the contractor's labour, while on duty, MSETCL will not be responsible in any way either legal or financial for the accident to the contractor's labours and the same shall be at the risk and cost of the contractor. The contractor will have to pay the compensation as per Workmen's Compensation Act to the Labour.
14. Contractor's Responsibilities:-
(a) It is the responsibility of contractor to maintain the discipline of his workers and himself and any hindrance, misbehavior towards MSETCL staff will be viewed very seriously and the contract will be terminated without entertaining any financial claim of the contractor in this regard.
(b) In case there is any damage to MSETCL's property or to any other contractor's property or to the MSETCL employee or to any other contractor's persons, due to careless working of the contractors labour, the same will be recovered from the contractor
(c) Your workers and supervisors shall be aware of all Security Rules and Regulations in CSTPS area.
15. The work will have to be carried out as and when the clearance is given by the Sub-station authorities. No compensation for idle time and idle labour shall be entertained by MSETCL on what so ever ground.
16. Company's Property : Any damage or loss to the company property due to your personnel negligence during the execution of the contract, you will have to make it good at your own cost.
17. **AGREEMENT: -**
You will have to enter an agreement with the company, in the prescribed format on bond paper of **Rs.500/-** at your cost within 7 days from the date of the receipt of this order as per the D.O. letter No. Mudrank-2009/2707/Pra.Kra/26/M-1 dated 09/10/2009 and CO.'s Adm.Circular No.207 dated 17/4/2010. The stamp fee will be born by agency.
18. **SUBLETTING OF CONTRACT:-**
Sub-letting of the contract will not be allowed otherwise the contract will be terminated and the security deposit shall be forfeited.
19. The right to reject any or all bids in part of full is reserved by the undersigned
20. Apart from the above points, all the Terms & Conditions Published by M.S.E.B. in Booklet "Tender & Contract of Works" are applicable here also.

21. No Extra Claims will be entertained on any account.

22. Jurisdiction :- All disputes or differences arising under/out of or in connection with this contract, if concluded, shall be subjected to exclusive jurisdiction of Chandrapur Court.
