TERMS AND CONDITIONS:

- 1. The EMD and Tender fees is to be paid online on the account of MSETCL through website https://srmetender.mahatransco.in. Due Date:-. 19.09.2022 upto 10:00 Hrs.
- 2. Documents should upload the following digitally signed scan copies of documents/certificates online under **Technical Bid.**
 - •Submit the performance /Experience certificate for similar nature of work at any HVDC station in India.

The performance/experience certificate shall be issued by the officer not below the rank of Ex. Engineer. The bidder shall also submit the copy of the work order mentioned in the experience certificate

Commercial Bid.

- PAN Card of the firm/proprietor as the case may be. Income Tax return for last three year.
- Certificate of Registration for GST with latest paid Challan.
- P.F. Registration.
- Valid Electrical Contractor License and Shop Act License.
- Valid Workman Compensation Policy. Valid insurance policy from M/s. United India Insurance Co. Ltd., on co insurance cum servicing basis in the ratio of 40:60 (i.e. the Govt. Insurance fund @40% and the United India Insurance Co. Ltd., @60% which will be valid for 2 years from the date 01.12.2013) entrusted by Director of Insurance, Govt. of Maharashtra. The INSURANCE will be required at the time of execution Before issue the purchase order
- List of skilled personnel's along with qualifications.
- For execution of work, all T&Ps should be bring by agency personnel during annual outage such as CRC, Polish paper, blower, Jelly etc & extra material and T&P will not be given by MSETCL.

- Annual Turnover for last 3 years duly certified by Chartered Accountant should not less than 60% of the estimated cost.
- Net Worth of last 3 years duly certified by Chartered Accountant should not be less than 20% of estimated cost.
- Solvency Certificate for the Current Year last 06 month equivalent to an amount not less than 25% of the estimate cost of work. It should be drawn on schedule/nationalized Bank.
- 3) RFx fee is Rs.118/- including taxes (Is non refundable)
- 4) If the above documents are not applicable then submit Eligible/ Non eligible documents list.
- 5) Within seven days from the date of receipt of the work order, the contractor shall have to enter into an agreement with the Company for the satisfactory completion of the contract in the approved Performa of agreement of the Company. Until such agreement is executed, the Company will not be liable to pay nor shall the contractor be entitled to claim amount due or payable, if any, under the contract. The cost of necessary stamp paper for the agreement shall be borne by the contractor.
- 6) Rates should be exclusive of all taxes & GST should be Mentioned Separately.
- 7) Before issue of work order, the contractor will have to pay security deposit of @ 5% of the order value on any scheduled, private or nationalized bank either by
 - i) F.D.R. or D.D. drawn in favor of MSETCL, Padgha or by RTGS
 - *ii) B.G.* drawn in favor of Superintending Engineer, HVDC RS (O&M) Circle, MSETCL, Padgha. Same will be refunded after expiry of order period. No interest will be paid on this deposit.
- 8) Contractor will have to make good damages, if any, made by him to the M.S.E.T.C.L.'s property during the execution of entire work at his own cost, otherwise the same will be got done by the M.S.E.T.C.L. at contractor's risk and cost.
- 9) Contractor will be responsible for any type of accidents to their workers occurring during the entire course of work and he will have to pay compensation whatsoever as per the prevailing "Workman's Compensation Act"
- 10) Income tax, Insurance, Labour cess, GST as applicable will be recovered from the bill on the total value of the work done as per the prevailing rates for which necessary certificate will be issued from this office.
- 11) Rates should be valid for 120 days.
- 12) Rates should be exclusive of all taxes or all applicable taxes and their charges should be mentioned separately and clearly in percentage.
- 13) Agency should be rate quoted at Estimate cost on Percentage (%) basis.
