Sealed & Superscribed online bids are invited on or before **dt.14.10.2022** for Transportation, loading & unloading of 132kV Babhaleshwar-Rahuri Ahmednagar MIDC line Material from Site store to MSETCL Store/substations as per enclosed **Schedule 'A'** with following terms & conditions.


**TERMS AND CONDITIONS:-**

1. The said work should be carried out in accordance with the particulars and description enlisted in the enclosed Schedule-A.
2. The rates should be quoted on firm quotation basis including labour charges, T&P etc. required for execution of the work, transportation charges, & taxes if any.
3. All the instruments, T&P, vehicles, labours e.c. shall be arranged by agency. No T&P or labour will be provided by the MSETCL.
4. The Contractor should furnish details of
  - (i) Registration Certificate of the firm as per Bombay Shop Act with renewal details.
  - (ii) GST registration certificate.
  - (iii) Copy of PAN card.
  - (iv) Order copies/Experience Certificate for similar type of works preferably in MSETCL or Government/Semi-Government/Private organizations. Order copies/Experience Certificate issued by authority not below the rank of Executive Engineer in case of Government/Semi-Government organizations will be required to be submitted.
  - v) EMD/Tender Fees Taxes will be applicable as per rule.

5. 5% Security Deposit is to be deposited in Cash/Crossed DD/Cheque before commencement of work. The same shall be refunded to you after the satisfactorily Completion of the work.
6. MSETCL will not be responsible if any damage is occurred to the contractor's equipment/T&P OR any accident to contractor's labours /personnel during work execution. Also, MSETCL will not be responsible if any theft/loss of contractor's material is occurred.
7. Any kind of loss to the MSETCL's property observed during the course of execution of work, by contractor's labour due to wrong operation shall be recovered from the bill.
8. Income tax will be deducted as per prevailing rules from the bill & a certificate to that effect will be issued to the contractor.
9. The work should be completed within 15 days from the date of handing over of clear work site, failure of such; penalty equal to ½ % per delayed week subject to the maximum of 10% of the ordered value will be levied.
10. The work should be strictly carried out as per standard specifications and up to the entire satisfaction of the Engineer-In charge.
11. The contractor will be abiding by the Rules & Regulations in force in respect of his employees & workmen under the Workmen's Compensation Act & the Contract Labor Act etc. He should be a registered contractor & documentary evidence of the same should be produced.
12. As per provision of 'Mumbai Mudrank Adhiniyam, 1958 clause No.34' an agreement on appropriate value of stamp paper (Not less than Rs.500/-) shall have to be executed with MSETCL for execution of contract satisfactorily before commencing work. The amount of the fees for such an agreement shall be borne by contractor.
13. Right to accept any or to reject any or all the quotations without assigning any reasons thereto is reserved by the undersigned.
14. The quantities enumerated in attached Schedule 'B' are approximate & payment will be made against actual executed quantities.
15. The rates quoted should be valid for 60 days.
16. Idle charges for any reason will not be accepted.
17. Not contained herein all other terms and conditions of MSETCL will be applicable to this enquiry.
18. In case of any dispute regarding this contract, the jurisdiction of the court will be Nashik.
