- 6.** The successful Bidder shall pay 5% of the contract value towards security deposit within 15 days from the date of acceptance of his offer.

7. Agency will have to execute an agreement bond on Govt. Stamp paper of Rs. 500/- within 15 days after receipt of work order at your cost.
8. Vehicle owner must bear the expenditure towards the Diesel / fuel, oil and repairs major/minor works and driver charges.
9. If the particulars vehicle allotted against the order is off the road for longer/ short duration for major/ minor repairs, the alternate vehicle shall be provided as the replacement on the same terms & conditions of the order having necessary RTO document & Tourist Permit document along with all statutory taxes paid. If you fail to do so, arrangement, if made by MSETCL by other vehicle, the charges whatsoever paid will be recovered from bidder's bill other than penalty clause.
