- Name of work: Providing diesel vehicle (TATA SUMO/Bolero or above Equivalent) along with driver on hire basis for 312 days (12 Months) for Addl. Ex. Engineer, Mobile Testing Unit, Karad under Protection-Automation-Communication circle, Karad.
- 2) The rates quoted per day on the firm basis. Taxes shall be quoted extra, otherwise it will be presumed that rates are inclusive of all taxes.
- 3) Only Diesel will be supplied by the MSETCL.
- 4) Your Service Tax / PAN No/ GST No. etc. must be mentioned in quotation.
