TERMS AND CONDITIONS:

1) Technical and Financial Criteria -

- a) You will have to submit the GST registration certificate.
- b) The bidder must have executed such type of work as mentioned in the scope.
- c) The bidder should submit the copy of Pan Card.
- d) Proof EMD/ Tender fee paid. As per circular published by corporate office in r/o exemption of EMD for SSI & NSIC Certification unit it is to indicate the following condition in field enquiry as follows:- "Firm/bidder has to pay EMD in respective of SRM system ask for the same or not in the following cases,"
 - I. If SSI/NSIC certificate do not indicate material/service required against present enquiry.
 - II. If turnover of manufacturing capacity exceeds the limit indicated in SSI/NSIC certificate specified by the concerned authority to avail the benefit of EMD exemption. IF require EMD is not paid by the bidder the office is liable for rejection.

4) Period of Contract : Time limit allowed for the completion of above work is up to dt.31.03.2023 from date of issue of LOA/WO.

6) **Bill** - You have to submit the bill in triplicate at the rate as indicated in Schedule 'A' in the name of EHV Project Division Kalwa.

7) Income tax or any other taxes will be recovered from your bills on the total value of work done as per prevailing rates.

8) **Payment Authority**: The Executive Engineer, EHV Project Division Kalwa.

9) Any loss or damage to the departmental assets or any other property by the person provided by you will have to borne by you.

10) In case of delay the contract may be terminated by the competent authority as per the rules and regulation of MSETCL and balance supply is any shall be got cost through separate contract at the risk and cost of tenderer.

11) The work should be carried out as per standard and as per satisfaction of Engineer Incharge.

12) The offer should be valid for our acceptance for period of 30 days from due date of opening.
