Transportation contract for transportation of substation equipment's and other accessories under EHV O&M Division Kolhapur.

Terms & Condition

- 1) Security Deposit: You will have to pay Security Deposit 5% of order value before issue of work order.
- 2) Supervision of Work: The work shall be carried out under the Supervision of Sub-station incharge.
- 3) Scope of work—Scope of work will be as per schedule A & as per the instruction of concern substation In-charge. Transportation of material with proper loading and unloading with crane or manually should be arranged as per direction of substation incharge and points mentioned below.
 - 1) Agency should use reasonable capacity of vehicle for transportation of material.
 - 2) Charges for minimum distance of 50 KMS for transportation of material will be payable.
 - 3) Charge for minimum weight of 9MT per truck will be payable.
 - 4) Vehicle should be loaded for transportation of material to its optimum capacity. Other wise no payment will be done. Oversize vehicle and under capacity loading should be strictly avoided.
- 4) Working period: Material should be transported from one location to other within 48 hours from the Dt of intimation given by substation incharge. Substation incharge should keep the record of the same for further bills processing.
- 5) Penalty: In case of work is not completed as per schedule within 48 hours from the Dt of intimation, the contractor shall be liable to pay penalty @ ½ % per week subject to maximum 10% of order value.
- 6) Crane and manual labour Agency should hire crane and manual labour for work of material loading and unloading at both the locations.
- 7) Vehicle for transportation of material Agency should provide required capacity of vehicle only for transportation of material. Vehicle used for transportation should be in good condition. Any damage occurring to MSETCL material will be recovered from agency bills.
- 8) T&P All required T&P required for material transport will be provided by agency.
- 9) You shall abide with all Govt. rules, regulations, status for this work including workman compensation act etc.
- 10) Workmanship and quality of Materials: The workman ship should be standard and material should reach in good condition from one point to other.
- 11) Agreement Bond: You have to execute the agreement bond on Govt. Stamp paper of Rs. 500/-before issue of work order. Cost of stamp paper will be borne by you only.

- 12) Accidents:-Any accident to your labour or vehicle during the execution of work, any loss/damage to MSETCL property will be on your account and you will have to make it good at your cost.
- 13) **Risk & Cost:-** In case you fail to complete the work fully or partly, the balance work will be completed from other agency and difference in cost will be recovered from your bill and security deposit in this case will be forfeited to Company.
- 14) Insurance:-The Insurance of your labour at your cost only. If fail the compensation / Claim arrears will be at your risk
- 15) MSETCL will not provide accommodation to your technicians / Supervisor, Labour, The transportation of materials / labours will have to be done at your cost.
- 16) Payment/Bills: Substation wise bills will be paid to agency after certification from concern substation incharge and availability of funds in reasonable time.
- 17) **GUARANTEE:** Not applicable.
- 18) All disputes / differences arising under/ out of or in connection with the contract shall be subject to the exclusive jurisdiction of Kolhapur court only.
- 19) The MSETCL Terms and Conditions of work contract are applicable for this work.
- 20) 1% labourcess½ % TDS will be deducted from your bills.
- 21) Monitoring of Order amount:-**Total Estimated Amount Rs. 3,00,000/- (Incl. GST &Labourcess).** You should have to monitor work order amount. If the work exceeds beyond work order amount, excess amount will not be paid at any cost.
- 22) Undersigned reserve the right to cancel order in part or full at any time without giving in notice.

Firm / Bidder has to pay EMD irrespective of SRM system asks for the same or not in following cases:

- 1) a) The Micro and small enterprise (Only manufacturing and service enterprise) as defined in MSMED Act, 2006 are exempted from paying EMD and tender fees. The UdyogAadhar Memorandum and UdyogAadhar Registration certificate submitted by said enterprises should indicate the same material / service as required against the tender floated.
 - 2) The Bidder has to pay EMD and tender fees in following cases:
 - a) If the micro /small enterprise registration certificate does not indicate the relevant classification code covering material / service as required against the tender floated.
 - b) If investment in the plant and machinery or equipment exceeds the threshold limit indicated in the MSMED Act, 2006 (at present the threshold prescribed limit being for

- 3) In case of works contract, if the Micro small enterprise submits that the enterprise shall supply all the materials of intended works contract, manufactured from its own unit, then it shall be eligible for exemption of payment of EMD & tender fees to MSETCL. However, an undertaking duly notarized from micro and small Enterprise to this effect is to be submitted along with bid.
- 4) The works contractor except as stated above and Traders are excluded from the benefits of EMD and Tender fees, hence shall be required to pay EMD or Tender fees while participating for e-tender process at MSETCL.
- 5) The registration certificate as submitted by micro & small enterprise should be valid on the date of submission of bid and the validity of the same should be certified by the Chartered Accountants in practice.
 - *If required EMD is not paid by the bidder, offer submitted will be liable for rejection*.

Note:- 1) Right to call deviation for above documents will be reserved with the Executive Engineer, rejection of offer due to insufficient documents will sole responsibility of bidder.

- 2) Documents should be attached as per sequence mentioned for ease in scrutiny and avoid time delay. In case documents are misplaced in folders attached in SRM and not found, rejection arising due to this will not be responsibility of this office.
- 3) Objection regarding qualification / other if any of respective bidder should be raised within 72 hrs from opening of technical bid or commercial bid at respective stage of tender process. No any objection will be entertain there after.
