8) EXECUTION OF WORK: -

In the event of the tender being accepted in the whole, the successful tenderer, hereafter referred to as the contractor shall execute order immediately as and when required per Schedule "A" enclosed within required outages provided by MSETCL.

9) COMPLETION PERIOD: - Work should be completed within **Six Months** from handing over of Site from MSETCL. Period specified shall be strictly adhered to the being, the essence of contract. - **23) COMPENSATION:-** If any accident occurs to any of your worker/your Supervisor/or outsiders in carrying of the work will be on your account. The Company will not be responsible for such accident/compensation payment etc.
 - **24) IDLE LABOUR HOURS:**-In case of suspension of work, or delay in work due to any reason or stay order of the Court of Law no compensation will be paid by the Company for idle labors /idle machinery etc., during the period.
 - 25) **PRICES:-** The rates quoted should be firm and Inclusive of GST.

26) INCOME TAX & WORK CONTRACT TAX :-

Income tax & Work contract tax as per rules will be deducted from the contractor's bill.

- 27) In case the work is not executed partly or fully the balance work will be got carried out from some other agency even at higher rate and difference in cost will be recovered from your pending bill with the Company or Security Deposit will be forfeited in addition to above.
- **28)** All other Standard Terms and conditions prescribed by M.S.E.T.C.L., regarding work which is not stated here are also applicable to this contract.
- **29) QUALITY OF WORK / MATERIAL:** Quality of work to be carried out should be strictly confirmed to our specification, otherwise same will be rejected and contractor has to redone the same at his cost and risk only. Ltd.* on co-insurance cum servicing basis in the ratio of 40:60 (i.e. the Government Insurance Fund @ 40% and United India Insurance Company @ 60%. The Terms of Policy should be that it will cover all works execution period. If failed to produce the policy, one percent (1%) amount of work order value will be recovered for the same. The same policy will have to be submitted immediately after receipt of this work order to concern office before starting of work having policy period not less than the prescribed time limit of this order. 38) COMPANY'S RIGHT FOR SIMULTANEOUS CONTRACTS :-

In case, there is more than one contract in operation for the work covered under this contract, the Company reserves the right to operate any of the contracts depending upon contractual liability of other contract and/or other prevalent directives of the Company. The decision of the Company in this regard shall be final and binding on the contractor.

39) MEMBERS OF MSETCL NOT INDIVIDUALLY LIABLE :-

No officer or employee of the MSETCL shall in any way be personally bound or liable for the acts of obligations of the Company under the contract or answerable for any default or omission in the observance or performance of the acts, matters or things which are herein contained.

40) BREACH OF CONTRACT:- Noncompliance of any of the contractual conditions by you or your representative shall amount to breach of contract and you shall be responsible for the same and liable for consequences as per the contract terms.



41) Progress Report:- The Contractor shall submit monthly reports to the engineer in charge showing the progress of work execution with to this office. The Contractor shall be responsible for the proper dispatch, receipt and storage at the site of all equipment/materials delivered for the purpose of the Contract and also for notifying the engineer of the details of the deliveries and delay thereto. Should any plant and equipment be lost or damaged due to improper packing, transport, handling of cost to the Owner, the Contractor shall make best efforts to ensure that the replacement is arranged expeditiously so that work schedule is not affected.

- **42**) The undersigned reserves the right to place the work order to one or more agencies by verifying the experience of the agency for such type of work partly or fully limited to tender value depending upon the situation.
- **43**) The Competent Authority reserves the right to relax any of the above conditions without assigning any reason thereof.
- **44) JURIDICTION:-** All disputes, differences related to tender/ contract shall be subject to exclusive Jurisdiction of Sangli District Court.
