**Technical Bid.**

- Submit the Performance/Experience certificate along with work order for the same nature of the work and shall be issued by the officer not below the rank of Ex. Engineer.

**Commercial Bid.**

- PAN Card of the firm / proprietor as the case may be.
  - Income Tax Return for F.Y 2021-22.
  - List of T&P available with the agency for execution of the work.
  - Certificate of Registration for GST with latest paid Challan. (if applicable)
  - Turnover duly certified by Chartered Accountant should not be less than 60% of the estimated cost during the F.Y 2021 – 22. Certificate issued by Chartered Accountant must have 15 digit UDIN (Unique Document Identification Number) if issued on or after 01.04.2018.
  - Net Worth of last Financial Year 2021-22 duly certified by Chartered Accountant (with UDIN) should not be less than 25% of estimated cost.
  - Valid Govt. Electrical contractor license.
  - Shop Act License.
3. The Contractor rates should be in percentage (%) based on estimate cost.

4. Rates should be valid for 120 days from the date of commercial opening of RFX.
5. Rfx fee is Rs.118/- including taxes (Is non refundable).
6. If the above documents are not applicable then submit Eligible/ Non eligible documents list.
7. Income Tax will be deducted from contractor's bill, as per Govt. rules.
8. **Warranty** : 'The Contractor' will have to give a warranty / guarantee for material supplied for the period as specified by the manufacturer/OEM of the material from the date of receipt of material at site / work place as the case may be. The warranty certificate should be given along with the material. If the OEM warranty is less than One year the bidder shall give warranty of at least one year from the supply of material.
9. Rates should be exclusive of all taxes or all applicable taxes and their charges should be mentioned separately and clearly in percentage.

- **Scope of work: -**

- a) Half yearly service of 46 Nos. of split ACs installed at various locations. The broad scope for each of the ACs includes servicing of motor bushings, ground connections, checking of connections at the main plug, cleaning of blower and condenser fans, cleaning of air filter, cleaning the evaporator and condenser coils, checking the equipments, oiling the motor, checking the cooling efficiency etc. including all T&P and labour, as per directed by Engineer – in – incharge.
  - b) In the course of checking, repairs or replacement of any components (required if any) would have to be carried out by the agency as per schedule.
  - c) Refrigerant gas top up if required has to be done by the agency.
