TERMS AND CONDITIONS:-

1. The Rate shall be quoted on firm quotation basis.

The quotation should be sent under sealed cover duly super scribed as QUOTATION FOR Supply of 25Kg SF6 gas (with cyclinder) for top up of 132/220kV circuit breaker at various sub-stations under EHV O&M Division Nanded. (Enquiry No.

be quoted). Your quotation should reach this office on or before 02.01.2023 up to 15:00 hrs which will be Opened on the same day, if possible.

1. Quotation received after due date will not be considered. This office is not responsible for any postal delay.

2. Documents required:-The rate offer must be accompanied with the following valid documents.

- a. Shop Act Registration
- b. PAN Card copy
- c. GST Registration (if applicable)
- d. Valid authorization certificate of dealership from manufacturer.
- e. Product broucher (if available)
- 3. The bidder should not quote conditional rates related to quantity of work, payment terms etc. Rates should include general packing and forwarding charges.
- 4. Taxes: GST shall be clearly specified in the quotation.
- 5. Awarding Of Contract: The Company does not bind itself to award the contract to the lowest bidder. Eligibility of the bidder, submission of all documents, past record will carry due weight age while arriving at the decision.

- 8. Security Deposit:- Security deposit i.e. 10% of order value to be paid within 7 days in terms of cash/DD /Bank Guarantee of Nationalized bank/scheduled bank in favour of the Executive Engineer, EHV O&M Div. Nanded from the date of issue of order.
