**Subject:** E-Enquiry for Emergency work for Servicing, Repairing & Maintenance of battery sets & battery chargers at various substations under EHV O&M Dn-II, Pune.

Sealed & Superscribed quotations are invited on firm quotation basis for the works indicated in **Schedule 'A'** so as to reach this office **on** <u>10.01.2023 upto 18:15 hrs.</u> on following Terms & Conditions.

### **Terms & Conditions:-**

- A) The offer should be submitted in sealed envelope containing following documents as well as price bid super scribing the subject.
  - 1. Proof of valid registration of firm under Bombay shop & Establishment Act.
  - 2. GST registration certificate
  - 3. Photo copy of PAN No. of bidder
  - 4. The bidder should have a Valid Govt. Electrical Contractor's License.
  - 5. Work order copy of Servicing, Repairing & Maintenance of battery sets & battery chargers in MSETCL.
  - 6. For above work order, satisfactory work completion certificate is mandatory not below the rank of Executive Engineer.

If validity of any license/certificate expires during order period, you will have to renew the same & submit the copy to this office.

- 1. Quotations with incomplete details submitted without sealing or superscripting not submitted in prescribed format etc. are liable to reject. Offer on fax or e-mail will not be accepted. This office will not be responsible for delay in postal transit. The agency should not submit 'conditional quotation' such conditional offer shall be liable for rejection.
- 2. The documents of an offer shall be written legibly and free from erasers, overwriting or conversion of figures. Corrections where unavoidable shall be made by crossing out, rewriting, initialing and dating.
- **3.** The right to place an order for part or to cancel any or all quotations without assigning any reasons is reserved with this office.
- **4.** Validity period of offer should be not less than 120 days from the date of submission of offer.
- 5. Estimated Value: The estimated value is Limited to Rs. 1,00,000/- (Including GST & Cess).
- **6.** <u>Agreement:</u> Bidder has to execute an agreement on **Rs.500/-** Bond paper & the cost of agreement to be borne by the agency.
- 7. <u>Security Deposit:</u> The successful bidder has to submit Security Deposit @ 5% of the total value of the work order within 10 days from the date of acceptance. The amount will be refunded in the normal course of, after expiry of contract period subject to deduction, if any.

- **8.** <u>Guarantee:</u> If the works are found defective due to bad workmanship, the same should be replaced by the contractor free of cost, if reported to you within 12 months.
- **9. Quantities:** The quantities indicated in the **Schedule "A"** are approximate and may vary at the time of execution of the work as per site condition. The payment will be done for the actual quantity of work done.
- **10. Quality of material & Specification:** The contractor will be responsible for quality of material & workmanship.
- 11. The breakdown work should be attended immediately on intimation from concerned substation incharge/Executive Engineer & should be completed within minimum time period. The contractor's gang must reach the site within minimum time period after intimation(i.e.within 5 Hrs).
- **12.** Payment of Bill: Payment will be released against completion of work on actual measurement basis after certification of officer incharge.
- a) Tax invoice in triplicate along with **Guarantee Certificate**, **MOM/JMC**
- b) shall be submitted to E.E.,EHV O&M Div. II, Pune.
- b) Payment will be effected within reasonable time & as per availability of fund.
- C) You would not be entitled to claim any interest on amount payable to you.
- **13. Taxes and Duties:** Taxes will be applicable as per prevailing rate. Statutory deduction shall be made as per applicable.
- **14.** <u>Penalty of execution of work:</u> If you fail to carry out the work within stipulated time as mentioned above, he will be liable to pay penalty @ 1% per week (A week of 7 days or part thereof) subject to maximum limit of 10% of the total value of the order.
- **15.** <u>Technical skilled persons:</u> The contractor shall employ and provide on-site only such employees who is skilled and experienced for execution and supervision of works. The contractor shall provide housing accommodation to his employees. He shall also be responsible for any injury/accident to his employees, payment of compensation, etc. as may required to be paid eventually, shall be borne by the contractor himself. The contractor should ensure that his staff uses the requisite safety equipments. The employee should be insured against any such eventuality.
- 16. <u>Material/spare parts to be used in execution of the works must be of standard quality & duly checked by operating officer as per required specification. The work carried out without supervision will not be recorded and payment will not be released for such works which may please be noted.</u> The material available at site should be utilized first. If not available then only material should be procured.
- **17.** <u>Applicability of general conditions of contracts:</u> Not withstanding anything stated herein, the MSETCL's general terms and conditions of contract shall be applicable to the contract, as far as they are applicable to this contract also.
- **18.** The concerned SSI is hereby appointed as Operating Officer for this work.
- **19.** Accident: If any accident occurs to your labourer skilled or unskilled persons at work compensation if any is to be paid by you only. Idle labour charges will not be paid. All safety precautions should be taken during execution of work.
- **20.** <u>Risk and Cost:</u> In case you fail to complete the work entrusted to you partly or fully, the undersigned reserves the right to get the balance work carried out through other agency and difference in cost will be recovered from your bill and S.D. If the balance remained to be recovered the same shall be recovered from you.

- **21.** <u>First Aid Box:</u> The contractor should always keep and maintain First Aid Box for this work as a safety measure.
- **22.** <u>Jurisdiction of court:</u> If any dispute or court case arises, then Jurisdiction of court shall be Pune Court only.
- **23.** The rates should be inclusive of all mobilization charges, transportation charges, etc. Also Labour & T&P for the works will be on bidder's account. Required man power and machinery should be arranged by bidder.
