

Name of Project :- Shifting of Existing 220kv Padghe -Vasai Tr line and 100 kv Padghe Vasai Tr line through Multi ckt towers against the infringement crossing with M/s DFCCIL, M/s NHSRCL and M/s MMRDA proposed alignment at Nagale village wildlife clearance under wildlife protection act 1972.

1.	Collection of field details includes survey of the route, identification of Core/Protected Area, Eco sensitive zone & other details required by the wildlife warden division for the area to be diverted. Uploading of Part I & II on the Mahaparivesh portal along with required details, undertakings, Topomap, collection of khasara/village maps (colour or as per requirement of wildlife authority) and 7/12 abstract, 9/3, 9/4 abstract from Revenue Authorities and other pre-requisite documentation from respective authorities, typing and printing, KML files, Digital Geo-reference map & other documents necessary for uploading the wildlife proposal on Mahaparivesh portal against wildlife clearance under wildlife protection Act 1972. ``	
2	<p>Submission of hard copies to concerned wildlife warden division for scrutiny & further processing includes, taking require permission from wildlife warden in wildlife Sanctuary, National Park, Eco sensitive zone, forest patches for Drone survey & aerial video shooting of required resolution & completion of other technical parameters required by wildlife warden. User agency shall complete survey activity after receipt of permission by wildlife warden.</p> <p>Surveyor will verify & scrutinize the wildlife proposal of wildlife warden division. After clearance from surveyor, finalization of the area coming under wildlife sanctuary, National park, Eco sensitive zone, wildlife warden instruct as per surveyors observation to his ACF, RFO, Round officers& guards to physically inspect the site. Round officer along with his guards inspect the site & instruct for belt marking of the corridor (ROW), tree counting, tree stamping of the area coming under wildlife sanctuary, national Park & Eco sensitive zone. Round officer after inspection send his report to RFO (Wildlife).RFO after site inspection & along with tree estimate, maps & other details send this report to ACF (Wildlife). ACF wildlife recheck the area finalized under wildlife sanctuary ,National park, Eco-Sensitive area after detailed inspection on site & drawings ACF wildlife after raising certain queries and after compliances to the queries ACF (Wildlife) after site inspection & suggestion if any will send his report along with tree estimate, maps to wildlife warden.</p>	

3	Wildlife warden /division office scrutinize the proposal thoroughly and asked to include all relevant details and documents necessary for wildlife clearance, MSETCL shall provide collect and submit all the details, documents and drawings along with measures to be taken time to time. After satisfaction wildlife warden Inspect/Visits the site and asked for compliances if any & after receipt of compliances from MSETCL wildlife warden prepare his detailed report, submit his part-I & part-III along with information sheet, other relevant documents pertaining to wildlife & recommended to APCCF wildlife for further needful.
4	APCCF office scrutinize the proposal thoroughly and asked to include all relevant details and documents necessary for wildlife clearance, MSETCL shall provide collect and submit all the details documents and drawings along with measures to be taken time to time after satisfaction APCCF Inspect/Visits the site and asked for compliances if any & after receipt of compliances from MSETCL concern wildlife warden, prepare his detailed report submit his part-III along with information sheet, relevant documents & recommended to CWLW / PCCF Wildlife Nagpur for further needful.
5	CWLW/PCCF wildlife Nagpur office scrutinize the proposal thoroughly and asked to include all relevant details and documents necessary for wildlife clearance, concern APCCF wildlife and MSETCL shall provide, collect and submit all the details, documents and drawings along with measures to be taken time to time. After his satisfaction CWLW/PCCF wildlife Nagpur submit his Part-IV, report & detailed attachment of drawings, area statement , other relevant documents pertaining to wildlife received time to time from wildlife/MSETCL and recommends the same for considering of approval of STATE BOARD OF WILDLIFE government of Maharashtra.
6	<p>Mantralaya i.e. Government of Maharashtra office scrutinize the proposal thoroughly and asked to include all relevant details and documents necessary for wildlife clearance from concern APCCF wildlife, concern CWLW/PCCF wildlife Nagpur and MSETCL. All concerns shall provide collect and submit all the details documents and drawings along with measures to be taken related to them time to time. After satisfaction and after receipt of compliance from wildlife authority and MSETCL authority State government consider the proposal for SBWL committee meeting and inform accordingly to MSETCL for preparation of Power point presentation, proposed line KML's, wildlife sanctuary, National park, Eco-Sensitive area, depicted on toposheet. Also preparation of wildlife areas KML's. Moreover other details required time to time is also part of proposal. MSETCL shall comply proactively in the interest of proposal and early completion of project. Consultant/MSETCL should ready with all the knowledge and requisite drawings and details for the SBWL committee meeting.</p> <p>SBWL committee consists of Chair Person Hon'ble CM (Maharashtra state) includes representative each for the MoEF & CC, Maharashtra Police, Indian Army, Zoological Survey of India (ZSI), Botanical Survey of India, Bombay Natural History Society, Wildlife Institute of India, Wildlife Conservation Trust, and commissioners of both state fisheries and animal husbandry departments and other N.G.O's working for wildlife protection. Consultant /MSETCL shall answerable to nearly 31 head of varies departments of Maharashtra and NGO's.</p> <p>Government of Maharashtra after SBWL committee meeting publish MOM if proposal has been approved and asked CWLW/PCCF wildlife Nagpur for fulfillment of compliances in MOM.</p>

7	<p>Consultant/MSETCL has to follow up with the CWLW/PCCF wildlife Nagpur for subject to compliances of approved MOM to be fulfill which includes statutory payment and other compliances. CWLW/PCCF wildlife Nagpur asked his downward offices and MSETCL for early compliances including statutory payment. Consultant/MSETCL shall submit their report to concern wildlife warden. Wildlife warden after scrutiny & completion of short comings send his report to APCCF wildlife for further needful. APCCF wildlife then send his report to CWLW /PCCF wildlife for scrutiny & further processing of the proposal. CWLW/ PCCF wildlife Nagpur after scrutiny and compliance time to time moved proposal to state government. State government after scrutiny and completion of short comings will recommend the proposal along with part-V to MoEF & CC, government of India for approval of National Board of Wildlife.</p>	
8	<p>NBWL government of India office scrutinize the proposal consultant/ MSETCL shall be present For completion of queries raised by NBWL time to time without fail. NBWL office thoroughly scrutinize the proposal & complete the short comings in the proposal from wildlife and MSETCL. After satisfactorily completing the compliances the proposal has been put in the NBWL committee meeting, consultant / MSETCL shall provide collect and submit all the details documents and drawings along with measures to be taken time to time. Consultant/MSETCL should ready with all the knowledge and requisite drawings and details for the NBWL committee meeting. After satisfactory completion the proposal has been put ahead for NBWL committee meeting MoEF & CC Government of India.</p> <p>The National Board for Wildlife (NBWL) is a "statutory board" constituted under the Wild Life (Protection) Act, 1972 (wildlife act). It Includes 47-member committee, headed by the Prime Minister and the minister of environment, forest and climate change (environment minister) as vice chairperson. In addition to offices and institutions directly involved in conservation and protection of wildlife, the NBWL also has the chief of army staff, defense secretary, and expenditure secretary to Government of India as members. Further, the central government nominates 10 members who are eminent conservationists, ecologists and environmentalists.</p> <p>After satisfaction of all members of the committee NBWL MoEF & CC Government of India. Issues approval to the project and send MOM to state Government (CWLW/ PCCF wildlife) for further needful.</p>
