## Technical Bid.

- Submit the performance /experience certificate for similar nature of work carried out after 01.04.2018
- The performance/experience certificate shall be issued by the officer not below the rank of Ex. Engineer. The bidder shall also submit the copy of the work order mentioned in the experience certificate.

## **Commercial Bid.**

- Income Tax Return for last one year (FY 2021-22).
- Average Turnover duly certified by Chartered Accountant should not be less than 60% of the estimated cost during the F.Y 2021-22. Certificate issued by Chartered Accountant must have 15 digit UDIN if issued on or after 01.04.2018.
- Net Worth of last Financial Year 2021-22 duly certified by Chartered Accountant (with 15 digit UDIN), if issued on or after 01.04.2018, and should not be less than 25% of estimated cost.

- Shop Act License or NOC from Grampanchyat.
- Certificate of Registration for GST & latest GST paid challan.
- Constitution of the bidding firm Partnership deed, Articles of Association etc. as the case may be (if applicable).

- List of T&P available with the agency for execution of the work.
