- 7] Payment: Payment will be made by the MSETCL, C.O. Mumbai within 45 Days after satisfactory completion of the work, on receipt of your bill in triplicate and certificate obtaining from the Engineer incharge for the work executed. No advance payment will be done.
- 8] In case of any dispute regarding any clause of the work order or works, the decision of the undersigned will be final and binding on you.
- 9] You should not affect the transfer of work or any part of it to any other agency.
- 10] You will be covered under standard terms and condition contained in MSETCL tender and contract for the works.
- Jurisdiction: The jurisdiction of all legal proceedings / suits as regards to the works under contract will be under Mumbai District Court.
- Tax deduction at source: In accordance with I.T. Act 1961, I.T. will be deducted at source at the prevailing rates from the bills. Similarly any other tax deductible at source, if applicable to this particular contract, as per statutory (laid down by Central or State Government), will also be deducted from the bills at the prevailing rates.
