You are requested to send your offer for providing skilled/unskilled manpower at EHV Project Circle, MSETCL, Pune for the period of Three months or till finalization of outsourcing tender at this office, whichever is earlier. While submitting the offer the following conditions to be noted: -

1. The skilled person to be provided for the post of Typist should have passed SSC exam or its equivalent, Graduates preferred. Should know English and Marathi typing with appropriate Typing Speed. No experience necessary for those possessing Govt. Commercial Certificates. The unskilled person to be provided for the post of peon should have passed 4<sup>th</sup> Std Examination as per the revised qualifications of MSETCL.

2. The skilled/unskilled persons should have clear antecedents & should not have been involved in any criminal case etc.

3. The labour should be vigilant, alert, respectful & presentable while on duty. They should have good moral reputation & should be free from bad habits like alcoholics, theft etc. They should have weekly off as per rules.

4. The working timings will be 10.00 am to 6.15 p.m. for skilled & 09:30 AM to 06:45 PM for unskilled & should be followed strictly. The holidays will be as per the company's holiday list.

5. You will have to make arrangement of relievers for weekly off/ leave etc. at your cost.

6. The contract does not confer any right of employment in Company's Services

7. You should quote fixed charges per day as per Minimum Wages Act including GST no other charges will be considered.

8. Please quote rate under minimum wages Act 1948 and according to Zone. The office is situated in Rasta Peth, Pune.

- h) Current valid copy of registration certificate under Maharashtra labour welfare Board registration.
- i) Valid copy of Professional Tax both PTEC & PTRC and Proof /Return of last twelve month wise paid Challan .
- j) Udyog Aadhar Memorandum & Udyog Aadhar Registration certificate (if applicable)
- k) Declaration regarding not been blacklisted.
- Certificate of performance, completion of similar work in MSETCL / MSEDCL / other Govt.utilities within last three FINANCIAL YEARS(Previous to the date of submission of bid) issued by authorities not below the rank of Executive Engineer.
