## ANNEXURE 'A'

### Scope of Work

1. The scope of work involves Supply, Installation, Testing of SSL Certificate as per Annexure C for SLDC web application (STOA).
2. Validity of the SSL Certificate should be for period of One year from the date of installation of the SSL Certificate.
3. Bidder shall provide support for SSL Certificate for period of One year.
4. Technical support, Installation, upgrades, updates and applying patches should be provided during support period without any additional cost. The support should include fixes, patch upgrades and any other appropriate correction required for the SSL to be always on the latest available version.
5. Installation of SSL Certificate should be done on Linux server where web application of the SLDC have been deployed.
6. Bidder supplying the SSL Certificate shall forward the complete set of original manuals and software on CD or through some other feasible media.
7. The Bidder is required to study of its own, the MSLDC setup and the proposed requirements of SSL certificates to avoid any kind of confusion, what so ever. The bidder once quoting the rate will be responsible for the supply, installation and implementation of the SSL certificate as per the requirements of the MSLDC and its quoted rates for the same would be treated as net & final.
8. If required, Bidder shall be responsible for unlimited times reissuance & reinstallation of the SSL Certificate during the validity period of the SSL Certificate.

## **ANNEXURE 'B'**

### **TERMS and CONDITIONS:**

**Bidder should carefully read all the terms and conditions/ Instructions of the enquiry document and follow the same scrupulously**

- 1) The Bidder should submit copies of following along with quotation:
  - i. GST Registration certificate
  - ii. PAN
  - iii. Proof of firm being registered as shop establishment/firm/company, as applicable.
  - iv. Audited annual accounts including balance sheets and other financial Statements OR valid ITR for past Three financial years.
  - v. Annexure D (Undertaking)
  - vi. Experience: Bidder should have Experience of successfully completed similar works during the last Five years ending the last day of month previous to one in which the Enquiry are invited should be either of following.
    - (a) "Three similar completed works costing not less than the amount equal to 40% of estimated cost."
    - OR
    - (b) "Two similar completed works costing not less than the amount equal to 50% of estimated cost."
    - OR
    - (c) "One similar completed work costing not less than the amount equal to 80% of estimated cost."

**(Note - Similar works means Supply and Installation of SSL certificate license).**

**For experience purpose, amount pertaining to similar nature of work will only be considered instead of complete Work Order Value**

Copy of work order to that effect from concern department/ agency is required to be submitted at the time of submission of quotation.

Failure to provide the desired information and documents may lead to disqualification of the Bidder. The bidder should not be currently blacklisted by any Government/Government agency/Bank/ institution in India or abroad.

If required MSLDC may verify the authenticity of the documents submitted and if found fake documents or manipulated documents are submitted the vendor will be blacklisted by MSETCL.

- 2) **Supply of SSL:** SSL Certificate offered should be strictly as per Technical specification mentioned in Annexure 'C' & shall be subject to approval of consignee after testing.

- 3) When the Configuration / Specification / feature required is not available in a particular version, next available higher configuration version shall be offered. MSETCL will not accept the items with lower specifications.
- 4) The bids will be evaluated on the basis of specification / brand / make of the product as per MSETCL requirement. If considered necessary, the MSETCL committee may take the decision in this regards and decision of Committee would be final and binding to bidder.
- 5) Software licenses should be in the name of “Chief Engineer, MSLDC, MSETCL”
- 6) **Delivery Period:** The material should be delivered to the consignee within **30 days** from the date of receipt of order.
- 7) **Destination For Supply:** The material should be supplied at SLDC Airoli office during working hours 10:00 Hrs. to 17:00 Hrs. on working day.

**8) Consignee for supply:**

- 9) **Security Deposit:** You will have to pay security deposit amounting to **5% of the ordered value** through Cheque/DD/Bank guarantee/F.D.R. within 10(Ten) days from the date of receipt of order, otherwise it will be deducted from bill payable. The same will be refunded to you ONE YEAR after satisfactory execution of the order. In the event of unsatisfactory performance of the contract or non-compliance to T&C, Scope of Works this amount will be forfeited. No interest will be allowed on this deposit.
- 10) **Terms of payments:** You should submit your invoice in triplicate along with work completion report, mentioning category of the services with income tax section for TDS, after successfully completion of work of Supply, installation and testing of SSL Certificate. 100% payment will be affected to you within 30-45 days on the basis of actual measurement recorded by the engineer-in-charge. However release of payment may depend on availability of funds. There will be no advance payment against this supply order.
- 11) **Penalty for late delivery:** If the contractor fails to complete the work within stipulated period as above, penalty towards delay @ ½ % of work order value per week maximum extent of 10% of order value will be levied and deducted from bill for non-execution of work. For the purpose of penalty clause, the completion of works in all respects to the satisfaction of the MSETCL shall be considered to be applicable..
- 12) **Technical Support:** You will provide onsite services for any technical problem in the executed work for the period of **ONE YEAR in coordination with OEM.**
- 13) **Penalty for downtime:** The response time for attending the faults is Four hours (maximum) after it is reported to the vendor. The faults should be rectified within 24

hours or Next Business Day of reporting, failing which bidder shall arrange standby replacement. Else SLDC shall realize a sum equivalent to @ ½ % of work order value per week maximum extent of 10% of order value from the date of reporting to vendor as a penalty by the way of deductions from Security deposit amount. (During Technical Support Period)

- 14) **Quantity:** Material should be supplied as per specifications and quantity mentioned in enclosed Annexure 'C' only.
- 15) If the materials are not approved/received in good condition, the same shall have to be replaced in part or in whole as per case.
- 16) If any dispute arises, the decision of the undersigned is final and binding on you.
- 17) Partial supply/installation/configuration/commissioning will not be accepted by the MSETCL. No any payment will be made for partially executed work.
- 18) **Transit Insurance:** Any damage during transit will not be the responsibility of MSETCL and bidder must agree to provide a replacement at his cost. Transit Insurance will be borne by bidder.
- 19) No extra charges for transportation, T&P, labour, packing, insurance, excise, material etc. will be paid, it will be arranged by you only.
- 20) **Quality of work and Material:** Bidder will be responsible for quality of work and workmanship. The material should be supplied as per specification.
- 21) **Accident:** If any accident occurs to your labour skilled or unskilled, compensation if any, is to be paid by bidder only.
- 22) **Consignee for supply**

- 23) For any loss to the company's property during execution of work, the bidder will be liable to pay the equivalent compensation as per the recommendation of concerned engineer.
- 24) MSETCL will not be responsible for any accident (fatal or non-fatal) or injury to the personnel of the agency or any financial implication arising there from.
- 25) Apart from the above points, all the terms and conditions published by MSETCL in booklet "Tender & Contract of Works" are applicable here also.
- 26) All the terms and conditions for the supply, testing and acceptance, payment terms, penalty etc. shall be as those mentioned herein and no change in the terms & conditions will be acceptable
- 27) In case of dispute, if any, the legal jurisdiction of the court shall be **Mumbai** only.

28) **General Conditions:** Bidder will be deemed to be fully aware of the MSETCL's General conditions of contract for the supply of plant, equipment and material particularly in respect of security deposits, terms of payment penalty for late delivery etc. Any ignorance of these conditions will not exempt you from your liability to abide by the same. General conditions are applicable as per MSETCL Rules and regulations. Moreover, the right to reject any or all tender/Enquiry in part or full without assigning any reason is reserved by the undersigned. Also the undersigned reserve the right to alter/amend /cancel any or all the terms and conditions stipulated above at any time in the interest of company without assigning any reasons thereof.

29) **Bidder Integrity:**

The bidder is responsible for and obliged to conduct all contracted activities in accordance with the Contract using state-of-the-art methods and economic principles and exercising all means available to achieve the performance specified in the Contract.

30) **Bidder's Obligations during the Contract Period:**

The bidder is obliged to work closely with the MSLDC staff, act within its own authority and abide by the directives issued by the MSLDC.

31) **Confidentiality:**

The bidder will treat all data and information about the MSLDC obtained in the execution of his responsibilities, in strict confidence and will not reveal such information to any other party without the prior written approval of the MSLDC.

32) **Indemnity:**

The bidder shall indemnify the Government against all actions, suits, claims and demands brought or made against it in respect of anything done or committed to be done by the bidder in execution of or in connection with the work of this contract and against any loss or damage to the Government in consequence to any action or suit being brought against the bidder for anything done or committed to be done for the execution of this contract.

The bidder will abide by the job safety measures prevalent in India and will free the MSLDC from all demands or responsibilities arising from accidents or loss of life, the cause of which is the Service Provider's negligence. The bidder will pay all indemnities arising from such incidents without any extra cost to MSLDC and will not hold the MSLDC responsible or obligated.

The MSLDC may at its discretion and entirely at the cost of the bidder defend such suit, either jointly with the bidder or single in case the latter chooses not to defend the case.

33) **Termination Clause:**

MSLDC can terminate the work order by giving one months notice in advance, in case MSLDC observes that the services are not as per the requirements. In case of termination security deposit shall be forfeited.

34) Any parts/spares etc required for system restoration in event of Breakdown shall be provided by Vendor.

35) Office space and normal office facilities shall be provided by MSLDC.

36) Income tax will be deducted at the prevailing rate.

- 37) All the expenses shall be borne by the Vendor.
- 38) **Travelling Expenses:-** No travelling expenses will be reimbursed or paid to the services & Maintenance Engineers or any other staff for visiting offices of the MSLDC for maintenance work.
- 39) Any loss occurs to MSLDC property during execution of works, you should make it at good at your cost.
- 40) If any accident occurs to the contractor's labor, while on duty, department will not be responsible in any way either legal or financial for the accident to the contractor's labor and the same shall be at the risk and cost of the contractor. The contractor will have to pay the compensation as per workman's compensation Act to the labors.**
- 41) No increase, decrease, discount reduction or any other changes in the price will be acceptable after the opening of the quotation.
- 42) During the period of contract, no upward revision of charges will be accepted.
- 43) You shall abide to M.S.E.T.C.L. standard terms and conditions regarding work contract.**
- 44) **SITE VISIT:** Bidder are advised to inspect, examine the site / equipments and its surrounding and satisfy themselves before submitting their enquiry. A vendor shall be deemed to have full knowledge of the site / equipments whether he inspects it or not and no extra charges consequent on misunderstanding or otherwise shall be allowed.
- 45) Right to reject any or all quotations is the reserved by the undersigned
- 46) MSLDC does not bind itself to accept the lowest or any bid and reserves the right to reject all or any bid or cancel the Enquiry without assigning any reason whatsoever. MSLDC also has the right to re-issue the Enquiry without the Vendors having the right to object to such re-issue.
- 47) MSLDC may at its discretion abandon the Enquiry process any time before the issuance of Purchase Order.
- 48) Where there is a discrepancy between the amounts in figures and in words, the amount in words shall govern.
- 49) Only one rate should be quoted against each item; quoting of multiple rates against a single item will amount to violation of the enquiry clauses and the bid will be rejected.
- 50) Partial Bid will be summarily rejected without giving any reason/notice to the Bidder.
- 51) Bid should be in the format provided in Price Schedule (Annexure C) only. any other format for bid will be summarily rejected without giving any reason/notice to the Bidder.



52) No increase, decrease, discount reduction or any other changes in the price will be acceptable after the opening of the quotation.

**53) The rates quoted will be valid for 120 days from the date of opening of quotation.**

54) Any variation in the rates, etc. will not be allowed on any ground such as mistake, misunderstanding, typographic etc. after the Enquiry has been submitted. The quoted rate must include all charges including free replacement of spare parts.

55) During the period of contract, no upward revision of charges will be accepted.

56) If any dispute arises, the decision of the undersigned is final and binding on you.

**57) Signing Of Contract Agreement:** In case order is placed, you will have to enter an agreement with MSETCL, in the prescribed format on bond paper of Rs. 500/- amount (Amendment vide Maharashtra Stamp Act, 20 of 2015) at your cost within 7 days from the date of the receipt of order as per the D O ltr no. Mudrank-2009/2707/Pra.Kra./326/M-1 dtd 09.10.09. And Co. `s Adm. Circular no. 207 dtd 17.04.10. The MSETCL will not be liable to pay nor shall you be entitled to claim any bill amount due or payable under the contract until the agreement is executed with MSETCL. The necessary Stamp Duty for the agreement shall be borne by you.

58) Other Conditions:

- (a) Bid should be free from correction and erasures. Corrections if any should be attested.
- (a) The rate of GST prevalent on the date of enquiry, should be clearly indicated in the quotation itself, if it's not mentioned; it should be treated as inclusive.
- (c) More than one bid shall not be accepted from one party.
- (d) Conditional bids will not be accepted.
- (e) Any bid received after the due date and time shall be rejected.
