TERMS AND CONDITIONS

- Due Date:-** The RFx, complete in all respects, should be submitted between the period of **21.02.2023, 00:00 Hrs to 28.02.2023, 14:00 Hrs.** positively.
- Scope of Works:-** Work of Painting of Complete Power Transformer along with accessories with required Material as per MSETCL specification at various SS's under EHV O&M Div. Jalgaon. The detail scope of work mentioned in Schedule 'A'.
- Quoted Rates:-** You are requested to quote your unit rates for the items mentioned in the schedule on firm (percentage) basis. (**Please quote ex-works price in ex-works field & applicable GST in GST field**).
- Payment:** On completion of the job, the bill (in triplicate) should be submitted to the office of the Executive Engineer. The concerned Engineer incharge will verify and process the bill and submit to division office along with his certificate & MIGO/SES as applicable. The payment will be effected by this office within a reasonable time as per actual work done.

5. Documents required to be attached along with offer: - Bidder should upload the following digitally scan copies of original documents /Attested documents/ certificates online under technical bid.

- I. The Bidder should be Register under GST Act – Proof thereof.
- II. Valid Electrical contractor license.
- III. Valid registration under Bombay Shop Act or Registration as Industry as applicable.
- IV. In case of a partnership firm, a letter by all partners authorizing any one or more partner/ partners to deal with the company regarding this bid /contract.
- V. Agency has to submit the certificate of work experience having successfully completion of painting of Power TF/ICT duly signed by the officer not below the rank of Executive Engineer or equivalent in MSETCL or any other transmission utility during last 5 years. Please enclose the proof of order copy & Experience certificate.
 1. Single completed order for any of the above works for amount of at least 80% amount of the estimated cost,

OR

2. Two completed orders for any of the above works each having amount of at least 50% amount of the estimated cost,

OR

3. Three completed orders any of the above works each having amount of at least 40% amount of the estimated cost.

Note: The amount of successfully completed works under the work order in force will also be considered.

4. PAN card & Income Tax Clearance Certificate (last three years)/ Acknowledgements of Income tax returns filed (last three financial years) (FY 2019-20, 2020-21 & 2021-22) in the name of firm with UDIN number (if applicable).
5. Full name of quotation submitting firm & full address of the same.
 - a. Contractors name, permanent address & Address Proof.
 - b. Bank name, bank address, bank account details should be submitted.
6. Submission of proof regarding online payment of e-Tender fee & E.M.D. may please be uploaded.
- 6. Rates & Taxes:-** The Rates quoted should be valid at least for 06 months and should be including of all Labour charges & incidental charges including labour cess but excluding GST as per applicable rate & relevant act. Please quote your GST registration No. on quotation.
- 7. Work completion:-** The time period of Contract will be for 06 months only after hand over the site. Once Shutdown taken you have to complete the work within 03 days. To complete work within time limit agency has to arrange resources. Materials used should be standard and good in quality, also the quality of the paint being used for the painting work should be approved from the Executive Engineer, EHV O&M Division, Jalgaon or his representative.
- 8. Penalty:-** If the supply is not completed within stipulated period the penalty @ ½% per week subject to maximum 10% of the order value of work, will be levied. Loss to MSETCL property or equivalent etc. due to your negligence will be penalized & will be recovered from the bill.
- 9. Quality:-** The agency will be responsible for quality of work & workmanship. The agency shall obtain a certificate from the concerned SS incharge and Executive Engineer for having executed the works satisfactorily.
- 10. Particulars of the works...**
 - Painting of PTF will be per the instruction of Dy. Executive Engineer, 132kV Deepnagar ECR S/stn, 132kV Nimbhora S/stn, 132kV Old MIDC Jalgaon S/stn, 132kV Yawal S/stn, 132kV Pachora S/stn, 132kV Chopda S/stn, 132kV Savda S/stn, 132kV Dharangaon S/Stn. & 132kV NEW MIDC Jalgaon S/Stn under instruction of Executive Engineer, EHV O&M Division, Jalgaon and Schedule “A”.
 - The agency has to carry all the work in Live Switch yard i.e, 132kV level.
 - The agency has to provide Well Trained Labor for Painting.
 - The Painting Work Should be done during day period only with taking Shut down of PTF.
 - The agency has to work only on Dead Equipment's.
 - The Paint should be ISI Standard only.

- No Brush Painting allowed. Only Spray Painting with following Standard rules as per instruction from Executive Engineer, EHV O&M Division, Jalgaon or his representative.
- The contractor shall be responsible for any damage or loss to the Owner due to the contractor's activities in the premises of the Owner

11. Insurance:

You have to submit the comprehensive insurance for work order amount as may be necessary to protect your (contractor) interests & the interest of The MSETCL, against all risk valid up to the work order completion period. Any loss/damage to the equipment, during supply, handling, transporting, storage & erection, till such time the plant is taken over by the owner shall be to the account of you. You shall be responsible for lodging of all claims and make good for the damage/loss by way of repairs and/or replacement of the portion of the works damaged/lost. The transfer of title shall not in way relieve the contractor of the above responsibilities during the period of the contractor. It is responsibility of contractor to takeout all necessary insurance of materials/equipment/labour for execution of work for his liabilities direct/indirect and same must be attached with invoice otherwise 1% on work order value will be deducted from bill.(If any)

12. Income tax: - Income tax, GST TDS will be deducted as per Govt rules.

13. Security Deposit: - The Bidder will have to pay security deposit within seven days from the date of receipt of the LOI, amounting to **05%** of the value of the contract in the form D.D./F.D. of any Nationalized / scheduled Bank in the name of **Executive Engineer EHV O&M Division, Jalgaon, payable at Jalgaon at EHV O&M Division, Jalgaon office** or in the form of Bank Guarantee in favour of **Executive Engineer EHV O&M Division, Jalgaon** valid for one year **at this office**. The same will be refunded only after satisfactory completion of guarantee period.

14. Agreement: - You will have to execute agreement as per provision of Mumbai Mudrank Adhiniyam 1958, Clause No.34 with requisite stamp duty (Rs. 500/-) before issuing of final work order.

15. General: - MSETCL general Terms and Conditions for works are applicable to this contract. The undersigned reserves the rights to accept or reject any or all the Quotation without assigning any reason thereof.

16. The undersigned have the reserve right for relaxation of any condition mention above & also reserves the rights for cancellation of any or all quotations/enquiry without assigning any reason.

17. Acceptance of work order shall be treated as acceptance of these conditions of the e-enquiry by contractor.

18. Jurisdiction: All the disputes arising out of this contract shall have exclusive jurisdiction of court in Jalgaon area.
