Sealed quotations are invited from authorized contractors/bidders who are registered vendors of MSETCL for following work at SLDC, Kalwa on or before 28.02.2023 up to 15:00 Hrs. with following terms and conditions.

Terms & Conditions: ----->

- 1.) **Rates:** Rates quoted should be firm, inclusive of all applicable taxes/ charges such as duties, tolls etc. complete. Nothing extra will be paid on any account over the quoted rates.
- 2.) **Validity of the offer:** The offer shall be valid for 60 days from the date of opening the quotation.
- 3.) **Payment:** The invoice in duplicate along with delivery challan of the same may be submitted to this office. 100% payment will be released after completion of the work in satisfactory condition. Work completion report duly signed by maintenance engineer in charge. No Advance payment will be made.
- 4.) **Period:** Work shall be completed within 60 days from the date of issue of this order.
- 5.) Work should be carried out as per the Indian standard & practice & to the satisfaction of the site Engineer in-charge.
- 6.) **Security Deposit:** You will have to pay security deposit amounting 5% of the value of order within 7 days of receiving work order & the same will be refunded to you 12 months after satisfactory execution of the order. In the event of unsatisfactory performance of the contract, or non-compliance to T&C this amount will be forfeited.
- 7.) **Safety:** The work should be carried out as per standard & established engineering practices and taking all necessary precautions, safety measures as per practice as per safety rules.
- 8.) Whenever there is paucity of funds, the priority of payments of bill of various agencies will be decided by the undersigned and all the rights in this regard are

reserved with the undersigned and binding upon you. The contractor is not entitled to claim any interest/compensation due to delay in their payments of bills on account of paucity of funds.

- 9.) **Penalty:** If the contractor fails to complete the work as per order in stipulated time period penalty towards delay @ ½ % per week maximum to the extent of 10% of order value will be levied and deducted from bill for non execution of the work.
- 10.) If any accident occurs to the contractor's labour, while on duty, department will not be responsible in any way either legal or financial for the accident to the contractor's labour and the same shall be at the risk and cost of the contractor. The contractor will have to pay the compensation as per workman's compensation Act to the labors.
- 11.) **Insurance:** - You have to obtain Contractors All Risk (CAR) insurance & workman's compensation insurance from M/s United India insurance Co. Ltd. entrusted by Director of Insurance, Govt of Maharashtra on co-insurance cum servicing basis in the ratio of 40:60 (i.e. Government Insurance fund @ 40% and United India insurance Co. Ltd @ 60%), if applicable.
- 12.) If the above insurance policy not drawn then as per Govt of Maharashtra directives one percent amount (1%) of the contract value will be deducted and the same will be deposited to Director of Insurance, Govt of Maharashtra through cheque/Demand drafts.
- 13.) No extra charges for transportation, T&P and Labour, material etc will be paid, it will be arranged by you only.
- 14.) **Guarantee:** After the competition of work the contractor have to maintain the work done in good condition for 180 days, at your cost.
- 15.) Contractor will have to make good damages, if any, made by him to the M.S.E.T.C.L.'s property during the execution of entire work at his own cost, otherwise the same will be got done by the M.S.E.T.C.L. at contractor's risk and cost.
- 16.) The quantities mentioned in the attached Annexure 'A' are approximate and may vary during the course of execution. Contractor will have no claim for the alteration. However, payment will be affected as per the actual measurements, measured at site as per M.S.E.T.C.L.'s rules.
- 17.) Contractor will be responsible for accidents to their workers occurring during the entire course of work and he will have to pay compensation whatsoever as per the prevailing Workman's Compensation Act.
- 18.) You will have to submit self attested photo copies of following documents along with the quotation. In case of failure to do so, quotation shall be liable for rejection. Your quotation should have copy of following documents-
 - a. PAN Number
 - b. Registration Certificate of Maharashtra/Bombay Shops & Establishment Act 2018/1948 if applicable. If not then undertaking to be given along with.
 - c. GST registration

d. Work competition certificate/order for similar type of work i.e. Supply and installation of Smart TV or Supply & installation CCTV camera/Video surveillance system, S&I Smart Android Item, etc. Agency has to submit the certificate of experience for execution of similar type of works in government organization/PSU'S/Semi-Govt digitally/Reputed Private Firm/MNC'S signed by the officer not below the rank of Executive Engineer or equivalent in case of Private works with single work order amounting up to Rs.2,38,000/- in last five financial years.

- 19.) **Income tax & GST if applicable will be recovered from the bill on the total value of the work done as per the prevailing rates for which necessary certificate will be issued from this office.**
- 20.) Contractor shall have to pay service tax to the concerned authority as per prevailing rules.
- 21.) **The bidder must visit the site location to survey the site for the work that is to be carried out. In case bidders fail to submit site visit certificate to this office to Maintenance In-charge then sealed quotation shall not be considered.**
