3. **ACCEPTANCE OF OFFER :-** The Company does not bind itself to accept the lowest or any offer neither by any reasons assigned for rejection of any offer. If is also not binding on the Company to disclose any analysis report of the said offer.
4. **DISCARDED OFFER CONDITIONS:-**The Company reserves to itself the right to reject any or all offers which does not confirm to any of the conditions.
5. **PRICE:-**The rates quoted should be firm & price variation will not be applicable at any cost & conditional bid not accepted. The price should be quoted in order to supply of material at 400KV R.S. Karad.
6. **The bidder should quote his offer in percentage (%) below/par with respect to estimate rate/amount mentioned in Schedule A. in Memorandum attached herewith.**
7. All the documents of this Enquiry Schedule "A" and other accompanying documents shall bear the authorized signature of the bidder, failing which the offer will be liable for rejection
8. **DELIVERY:** The material should be deliver at Major Store Karad (Ogalewadi).
9. **EXECUTION OF WORK :-** In the event of the offer being accepted in the whole, the successful contractor shall execute the order immediately as per the order schedule within the time specified in the work order. The required T&P is in his own scope for execution of the said work.

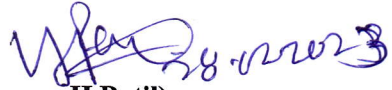
