The skilled person to be provided for the post of Office Assistant, LDC should have passed graduation examination & have computer knowledge and for the post of Typist should have passed SSC exam or its equivalent, Graduates preferred. Should know English and Marathi typing with appropriate Typing Speed. The unskilled person to be provided for the post of peon should have passed 4th Std Examination, The person for the post of technician should have passed ITI (electrical), NCTVT Examination as per the revised qualifications of MSETCL.
- 3. The labour should have clear antecedents & should not have been involved in any criminal case etc.
