TERMS AND CONDITIONS OF CONTRACT

1) SIGNING OF CONTRACT:

Within 7 days from the date of the receipt of this work order, the contractor shall enter into an agreement with the Company, in the prescribed format. Until the agreement is executed, the company will not be liable to pay, nor shall the contractor be entitled to claim amount due or payable under the contract. The necessary stamp duty for the agreement shall be borne by the contractor.

2) SCOPE OF WORKS:

The scope of works includes providing the services of prospective candidates for Testing Division, Karad. The candidates shall work as per the directions, and guidance of the respective.

The contract labour to be provided should be qualified / trained and well conversant with the work preferably knowledge of above work and minimum qualification any graduation with MSCIT for fresh candidate will be observed.

The contract labour should be vigilant, alert and respectful and presentable during the contractual period. They should have good moral reputation and should be free from bad habits like alcoholics, thefts etc;

The work is to be executed under the supervision of concerned authority in office hours. All terms and condition of work contract, prescribed by M.S.E.T.C.L are applicable to this order.

3) SECURITY DEPOSIT:

You should pay security deposit equivalent to 5% of the value of the order. Security Deposit is payable by (a) Cash (b) D.D. (c) Bank Guarantee from a nationalized scheduled Bank. The S.D. will be refunded after satisfactory completion of the work. No any interest will be given on S.D. deposited by contractor.

4) CONTRACT PERIOD:

The contract shall be operative for One year with effect from the date of actually engaging the candidates or expenditure of order amount from the date of order issued whichever is earlier.

5) OPERATING AUTHORITY:

Executive Engineer, Testing Division, Karad will operate this contract.

6) SUBMISSION OF BILLS / PAYMENT OF BILLS: -

The bills for the work as per Schedule 'A' should be submitted in triplicate, to the Executive Engineer, PAC Division, Karad. You will have to make payment to your contract labour as per Minimum Wages Act 1948 & MSETCL/ED/HR/CIRCULAR No.142 Dtd.03/01/2014 amended up-to-date and evidence of payment made to your labour should be submitted to this office.

7) PENALTY FOR DEFAULT:

Penalty @ 1% per day rate will be deducted from your bills as penalty in case you default in providing LDC cum computer operator services during any day. The deduction will be limited to the actual period of default maximum 10% of order amount.

8) TAX DEDUCTION AT SOURCE:

In accordance with I T Act 1961, Income Tax will be deducted at source at the prevailing rates from the bills as 2%. Similarly any other tax deductible at source if applicable to this particular contract as per statutory provisions (laid down by Central or State Government.) will also be deducted from the bills at the prevailing rates.

9) DAMAGE TO PERSONS AND PROPERTY:

The contractor shall indemnity the EHV Company against any losses and claim in respect of injuries or damage to any persons, material or physical damage to any property what so ever, which may arise out of or in consequence of the execution of the work.

10) TERMINATION OF CONTRACT:

The undersigned reserves the right to cancel the contract, after giving due notice to the contractor, in the event of the breach of contract and unsatisfactory services in any respect.

11) JURISDICTION:

All disputes, differences related to the tender / contract shall be subject to the including jurisdiction of Karad Court.
