Sealed & super scribed quotations are invited on firm quotation basis for the works indicated in schedule 'A' so as to reach this office **on or before 21.03.2023 up to 18.00 hrs.** on following Terms & Conditions.

Terms & Conditions:

1) The offer should be submitted in two separate sealed envelopes contained in one main envelope super scribing the subject.

Envelope 1: Should contain associated documents/Certificates/proof of qualifying pre-requisite Broachers attested certificate etc such as,

1. Proof of valid registration of firm under Bombay shop & Establishment Act.
2. Details & specification of material offered on agency's letterhead.
3. GST registration certificate
4. Photo copy of PAN No. of bidder
5. The bidder should submit the work order alongwith work experience certificate for **supply of handgloves related work in MSETCL/MSEDCL/MSPGCL/Power Sector, which should not less than 50% of estimated amount.** The work experience certificate issued by the officer not below the rank of Executive Engineer

Envelope 2: Price bid documents: This should contain only price bid in given schedule, not in any other format. After verifying full documents /certificated pre-qualification as above in envelope 1, if it is found that, bidder fulfills the desired prerequisites, envelope 2 will be opened. If the same is not meeting the prerequisites, Envelope 2 shall not be opened.

1. Quotations with incomplete details submitted without sealing or superscripting not submitted in prescribed format etc are liable to reject. Offer on fax or e-mail will not be accepted. This office will not be responsible for delay in postal transit. The agency should not submit 'conditional quotation' such conditional offer shall be liable for rejection.
2. The right to place an order for part or to cancel any or all quotations without assigning any reasons is reserved with this office
3. Validity period of offer should be not less than 120 days from the date of submission of offer.
4. The documents of an offer shall be written legibly and free from eraser, overwriting or conversion of figures corrections where unavoidable shall be made by crossing out, rewriting, initialing and dating.
5. **Security Deposit:** Bidder have to pay Security Deposit of 10% of the work order value within 7 days from the date of issue of LOI in the form of FDR/BG/D.D./UPI of any Nationalized/ scheduled Bank in the favour of "MSETCL at the office of The Executive Engineer EHV O&M DN-II, Pune valid for one year. The Security deposit will be refunded only after satisfactory completion of the work period. Also, you will have to apply for refund of SD within 6 months after completion of guarantee period. If you fail to apply within stipulated period, the action as per CO's rules will taken.

6. Before placing of W.O., the inspection of sample shall be carried out by committee appointed by this division for all the qualified bidders & W.O. will be issued to the agency whose material is approved by committee members.
7. **Delivery & time Period:** Bidder should deliver the material at **Substation Maintenance Unit Ganeshkhind** as per Schedule 'A' within **45 days** from the date of receipt of order.
8. **Guarantee:** The material should be of the best & standard quality & guaranteed for **1 year** from the date of handing over of Material to MSETCL. **In case of any defect, the contractor should replace the material if reported within guarantee period at their own cost.**
9. The T&P/ labour/ machinery/ equipment/ material required for the work shall be to your account.
10. **Packing/ Handling & Transportation of material:**
 - 1] The bidder shall be fully responsible for Packing, Forwarding and Transportation of material by any other authorized mode of transport, clearance of equipment and further transportation of site place to of work / storage yard etc., in respect of material in his scope.
 - 2] Bidder shall pack and crate all material in such a manner as to protect them from deterioration and damage during rail / road or any other authorized mode of transfer. The bidder shall be held responsible for all damages / losses.
 - 3] The bidder shall notify the Owner, date of each shipment from his work. The bidder shall give all shipping information concerning the weight, size and the contents of each packing including any other information the owner may require.
11. **Quality of material & Sample:** The bidder will be responsible for quality of material. The bidder should provide the material as specified in schedule 'A'. If the material is not as per requirement, you will have to replace the same at your risk & cost.
12. **Penalty:** If the bidder fails to carry out the work within stipulated time as mentioned above, he will be liable to pay penalty @ 1% per week (A week of 7 days or part thereof) subject to maximum limit of 10% of the total value of the order.
13. **The right to modify/ alter /cancel the quotation is reserved by undersigned.**
14. The bidder should be fully aware of the M.S.E.T. Co. Ltd. General Condition for execution of work and same is applicable to this contract also. Any of the condition will not exempt you from your liability to be abiding by the same.
15. **Taxes and Duties:** Taxes will be applicable as per prevailing rate. Statutory deduction shall be made as per applicable.
16. **Jurisdiction:** All disputes or differences arising under/ out of/ or/in connection with this contract, if concluded, shall be subject to exclusive jurisdiction of PUNE Court only.
