### **TERMS AND CONDITION**

- 1. The rates quoted by you should be valid at least for one year & should be including of all duties & taxes but except GST.
- 2. The work shall be supervised by the Adnl. Executive Engineer, Line Maintenance S/Dn Amalner under EHV O&M Division, Jalgaon.
- 3. If any accident occurs during the work, the complete responsibility of the accident will be of contractors. The MSETCL shall not pay any type of compensation for any type of accident.
- 4. The work should be completed within stipulated period from the receipt of the order/intimation to you, failing which the penalty as per rules will be deducted from your bills.
- 5. Bidder should note that the utilization of the vehicle will be under the jurisdiction of EHV O&M Division, Jalgaon i.e. Sub-stations available under all geographical area of whole Jalgaon district. Also the vehicle will be utilized for Transportation of Diagnostic kits, minor spare parts, minor accessories to be utilized for S/Stns.
- 6. **Security Deposit being 05%** of ordered value will have to be paid in form of cash to this office before issuing of detail work order.
- 7. The Income Tax as per rules will be deducted from your bills.
- 8. The work carried out should be guaranteed for 12 Months.

- 9. 100% Bill payment will be paid to you on monthly basis by account payee cheque in reasonable time and as per the availability of funds after the satisfactory completion of work and as per SAP entries done by Addl. Executive Engineer, Line Maintenance S/Dn, Amalner.
- 10. Only diesel will be provided by MSETCL at the minimum assured average run of 11 KM/litre. If it goes below than that, the vehicle owner should bear the additional expenses on his account & same changes will be deducted from monthly bill. All the expenses regarding vehicle repair/Driver payment (Including OT if any) shall be borne by you. MSETCL shall not bear any responsibility on this account.
- 11. The Company will not undertake any responsibility if the RTO formalities are violated by you.
- 12. The vehicle will be hired for 2023-24 only or till receipt of Departmental vehicle or completion of order whichever is earlier.
- 13. The use of vehicle will be as per instructions from Adnl. Executive Engineer, Line Maintenance S/Dn Amalner as & when required.
- 14. All terms and conditions as per company's rules including those work in the MSETCL booklet. "Tender and contract for works" are applicable in this case also. Not with standing stated herein, the Company general terms and condition of contract shall be applicable to this contract also.
- 15. The undersigned reserves the right to reject any or all quotations without assigning any reason thereof.
- 16. Necessary RTO formalities such as RTO documents, RC/TC book, PUC certificate, comprehensive insurance certificate, T Permit, driver license and all relevant documents should be obtained from RTO (the same should be valid during the contract period and maintained continuous by you, and attested Xerox copies of original should be submitted to this office along with quotation. You have to take necessary permission if required from RTO Authority for hiring purpose). All rules regarding registration of vehicle of sales tax Mumbai should be observed by the owner of vehicle.
- 17. In case of failure/breakdown of this vehicle due to any reason, you will have to provide another same type of vehicle on same rate, terms & conditions, otherwise if the MSETCL has hired the another vehicle, the complete charges of the same hired vehicle will be recovered from your bill.
- 18. If the hired vehicle is not made available on any working day/days without convincing reason or without intimation. The penalty at rate of 10% of the daily charges will be levied for such every day at the discretion of under signed.
- 19. The Toll tax/Parking charges will be borned by MSETCL.
- 20. The hired vehicle must run on all types of roads. The condition of all tyres fitted to the vehicle must be in good condition. Good and serviceable Stephaney should be provided in the vehicle.
- 21. The hired vehicle has to run normally in the area of jurisdiction, under control of officer, for whom vehicle being ordered. However some cases the hired vehicle shall be required to run in the area, out of the jurisdiction of the controlling officer. (To whom the vehicle is allotted) within the jurisdiction of MSETCL occasionally. Secondly normal working hours per day shall be 8-10 Hrs & in exceptional cases the period may be more than this.
- 22. Vehicle maintenance, arrangement of driver and his salaries and allowance or any other expenditure
- 23. The vehicle should be registered within <u>last 05 years</u> & should be in good condition.
- 24. You should have to execute the agreement as per provision of Mumbai Mudrank Adhiniyam 1958, Clause No.34 with requisite stamp duty (Rs. 500/-) before execution of work to this Office.
- 25. The agency has to provide the Uniform to the driver as prescribed by the MSETCL, time to time.
- 26. The vehicle shall have D+4 seating capacity with material loading capacity of 01 MT minimum.
