## 1) Technical and Financial Criteria -

- a) You will have to submit the GST registration certificate.
- b) The bidder must have executed such type of work as mentioned in the scope.
- c) The bidder should submit the copy of Pan Card.
- d) Proof EMD/ Tender fee paid.
