This Office invites quotation in sealed envelope for above subjected works. Please quote your Offer Rates on your Letter head in line with Annexure - A enclosed herewith, subject to following terms and conditions.

# **Terms and Conditions:**

- 1. The Name of Agency, subject of bid and enquiry number must be mentioned on sealed envelope.
- 2. Quotation should be submitted to This Office (Personally or by Post) on or before 11:00 Hrs on 27.03.2023.
- 3. The Offer Rate shall be valid up to 31.03.2024.
- 4. Rates should be quoted in figures clearly.
- 5. The following documents shall be attached along with bid.
  - a) Valid Tourist Permit
  - b) Valid Registration Certificate (RC).
  - c) Valid vehicle Insurance certificate.
  - d) Valid Road Tax Certificate (TC).
  - e) Valid Fitness certificate / Passing certificate.
  - f) Valid as on date PUC.
  - g) Pan Card
  - h) Valid Certificate of Registration under GST (if applicable).
  - i) Valid Registration under Bombay Shops and Establishments Act, 1948, if applicable or No objection Certificate from Gram panchayat.

- j) Constitution of the bidding firm Partnership deed, Articles of Association, JV etc. as the case may be (If applicable).
- k) The bidder has to submit all 04 (Four ) undertakings ( attached ) on Agency Letter Head.
- Out of these 04( Four) undertakings, the undertaking no. 4 'Liable for penal action under IPC' is to be executed as an affidavit on Non Judicial bond paper of Rs. 500/- (Five Hundred) only. This document shall be submitted in hard copy at the time of submitting SD, Agreement & Insurance related documents after award of contract.

Bonds executed on any paper other than that of Govt. of Maharashtra will not be accepted for any reason.

# **General Mandatory Conditions:**

- 1. The vehicle must have been registered for the first time with RTO on or after 01.01.2019
- 2. The vehicle must be in good running condition with healthy brakes, Head Lamps, Tyres, Battery, suspension etc.
- 3. The Contractor' will have to execute & bear the cost of the routine & breakdown maintenance / servicing of vehicle along with replacement of any vehicle part or accessories (Including repairs of Tyre Puncture) during contract period. Any kind of wear tear of any vehicle spares/ tyres etc shall not be borne by MSETCL.
- 4. The cost of fuel, all type of oil & coolant etc shall be borne by The Contractor during contract period.
- 5. The driver must have valid RTO Licence during contract period. The monthly salary/ OT charges/ Night allowance of Driver shall be borne by The Contractor. The RTO fine for Over speeding, wrong parking, Signal crossing, Over jumping Zebra crossing etc shall be borne by The Contractor during contract period.
- 6. In every month, the vehicle shall run under Aurangabad & Jintur S/Dn for 15 days each as per the directives of respective S/Dn Incharge.
- Daily duty hours for 10 hours (08.00Hrs to 18.00 hrs.) excluding Sunday. If required the vehicle shall be made available at any time and on any day as per requirement during emergency of MSETCL line breakdown or other line maintenance activities.
- 8. Vehicle driver shall maintain daily vehicle dairy, daily tour shall be certified by S/Dn Incharge or MSETCL staff.
- 9. Monthly bill will be limited to Rs. 50,000/- only including GST.
- 10. No leave shall be granted for driver during contract period. In case the regular driver remains absent, then alternative arrangement of Driver with valid RTO license shall be done by The Contractor. MSETCL shall not pay the charges of this alternate .Driver.
- 11. If the regular vehicle is under breakdown, then The Contractor shall make arrangement of alternate vehicle with all valid papers. All RTO payments, insurance, PUC etc for alternate vehicle shall be the responsibility of The Contractor.
- 12. The vehicle Parking charges & Road Toll shall be borne by MSETCL during valid contract period.
- 13. The Contractor shall have to submit the valid driving license of driver after award of contract.
- 14. The Contractor shall be responsible for the proper maintenance/up keeping of the vehicle.

- 15. MSETCL will not be responsible for any causality to the driver or vehicle or third party person(s) or property in the event of meeting accident. In case of such eventuality, any kind of financial compensation shall invariably be borne by The Contractor only.
- 16. All valid documents of Vehicle & driving license must always be available with vehicle Driver during any tour during Contract period.
- 17. The MSETCL will not provide any parking facility for the Contractor's vehicle
- 18. The Contractor should provide the Vehicle with valid FASTag.
- 19. As per requirement, the vehicle shall be plied anywhere under jurisdiction of 500kV HVDC Jalna Division.
