Terms and Conditions:

1. The Name of Agency, subject of bid and enquiry number must be mentioned on sealed envelope.
2. Quotation should be submitted to This Office (Personally or by Post) on or before 11:00 Hrs on 28.03.2023.
3. The Offer Rate shall be valid up to 31.03.2024.
4. Rates should be quoted in figures clearly.
5. The following documents shall be attached along with bid.
 - a) Valid Govt. Electrical contractor license.
 - b) The relevant Experience Certificate for similar type of work issued by officer not below the rank of Executive Engineer in MSETCL along with Work Order.
 - c) The **work order(s)**(mentioned in Sr. No. (b) of the above) should have been issued on or after **01stApril 2018**
 - d) Income Tax Return of Financial Year 2020 – 21 in the name of bidding firm.
 - e) Pan Card
 - f) Valid Certificate of Registration under GST (if applicable).
 - g) Valid Registration under Bombay Shops and Establishments Act, 1948, if applicable or No objection Certificate from Gram panchayat.
 - h) An agreement on Non Judicial bond paper of Rs. 500/- (Five Hundred) only. This document shall be submitted in hard copy at the time of submitting SD, Agreement after award of Work Order.

Bonds executed on any paper other than that of Govt. of Maharashtra will not be accepted for any reason.

General Mandatory Conditions:

1. The Material shall be of standard make & shall be got approved from the undersigned before start of work..
2. 'The Contractor' shall employ and provide onsite only such employees who are skilled and experienced for execution and supervision of works. 'The Contractor' shall provide housing accommodation to his employees. 'The Contractor' shall also be responsible for any injury / accident to his employees, payment of compensations etc. as may be required to be paid eventually, shall be borne by 'The Contractor' himself. 'The Contractor' should ensure that his staff uses the requisite safety equipment.
3. All required T&P shall be provided by The Contractor. MSETCL shall not pay cost for use of T&P
4. If any accident occurs to Contractor's labors during the supply of the material / works being executed, 'The Company' or any of its employee shall not be responsible for the payment of any compensation to them. In such cases, it would be entirely the responsibility of 'The Contractor' to pay the compensation as per 'The Workmen Compensation Act, 1923' and subsequent amendments thereof made there under.
5. If 'The Contractor' fails to pay the same, it will be recovered from the bill due for payment to 'The Contractor' by 'The Company' and will be paid to the concerned persons or his dependent / heirs / Govt. Authority etc. as required under the rules and regulations in force from time to time.
