- 1. Scope of work: As per Schedule "A".
- 2. The quotation should be sent under sealed cover duly super scribed as QUOTATION FOR the work of Providing and Fixing of Solar powered LED flasher as line route indicator for 400kV Kumbhargaon-Chandrapur ckt-2 D/C LILO Line under 400 kV LMSD Kumbhargaon under 400 kV R S Kumbhargaon, Nanded. The quotation complete in all respects i.e. Offer rates should be filled in given work Schedule "A" format copy, Duly signed, sealed & super scribed, along with covering letter of bidder/agency with above mentioned subject. (Enquiry No. be quoted).
- 3. **Quoted Rate:** The Rate shall be quoted on firm quotation basis, for the particulars mentioned in Schedule "A". Taxes and charges should be mentioned clearly. If not mentioned, rate quoted will be considered as inclusive of all taxes.
- 4. Important Dates: Quotations invited from 25.03.2023 from 10:00 Hrs, so as to reach this office up to 31.03.2023 up to 17:00 hrs and the same will be Opened on the same day, if possible. Quotation received after due date will not be considered. This office is not responsible for any postal delay
- 5. Taxes: Taxes will be paid & recovered, as per rules.
- 6. Order value: Order value is limited to **4,88,842.49**/- (In Words: Rupees Four Lakh Eighty Eight Thousand Eight Thousand and Forty Two only) inclusive of all Taxes.
- 7. **Payment:-**100 % payment will be made after satisfactory completion of the work & on receipt of bills in triplicate (Indicating PAN No., GST Reg. No.) to 400 kV LMSD Kumbhargaon along with test certificates (if any), and advance stamp receipt for arranging payment. No part payment will be made.



- 8. **Paying Office:-** The payment against this contract will be effected by Executive Engineer, 400 kV R S Division Kumbhargaon, Nanded within reasonable time as per funds availability.

 - D. Experience certificate for execution of the similar kind of work related to 400kV Lines from the authority not below the rank of Executive Engineer of MSETCL.
 - E. Site visit & sample approval from the office incharge nominated by the EE, 400 kV RS Division Kumbhargaon, before submission of response.
- 13. The rates offer submitted by you should be valid for at least 90 days from the last date of receipt of quotation.
- 14. **Material/Item Specifications:-** The materials offered should strictly conform to the specifications mentioned. Wherever asked for, the necessary test certificates must accompany the consignment. If necessary, the material will be tested before / after delivery to ensure that it conforms to the specifications. If the same is not conforming, then the whole lot will be liable for rejection.
- 15.Execution of the work:- Should be standard and upto the full satisfaction of the site incharge.

	Providing & fixing of Solar powered LED flasher as line route indicator of suitable light illumination / intensity so as it should be clearly & distantly visible even during foggy / dusty weather in dark hours, with automatic power cut off circuit during day light and switch on during night hours and the solar cell should necessarily have minimum 12 hours of continious battery life, irrespective of solar cell face direction and dust deposits should not decrease it's efficency. The light should be fixed on Top cross arms of either side of 220kV D/C line of R-phase for clear visibility. And to R & B phase of S/C horizental line. The colour of LED should be warmth colour (orange / yellow / red) for distant visibility.
