12. Any damage to any properties during execution of work shall be at the contractor account and cost of such damage will be recovered from him.
13. The contractor should observe necessary safety precautions, accident if any will be at the account of contractor.
14. **Shortages:-** All Shortages, if any will be at the cost of supplier.
15. **Safety:** - The contractor should observe all safety precautions during execution of work.
